MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

The Petitioner, Jasper Pollini, asks leave to file the attached Petition for a Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis* pursuant to Rule 39. As basis for this motion, Petitioner states the following:


1. Petitioner is indigent.
2. Petitioner was appointed counsel by the Kentucky Supreme Court pursuant to KRS 31.110(2)(c), which authorizes the appointment of counsel in post-conviction actions. Counsel was authorized to continue representation throughout the underlying habeas corpus action under KRS 31.220(1), which authorizes continued representation in United States Courts.

3. Petitioner he has been declared indigent and allowed to proceed in *forma pauperis* on this appeal. See May 6, 2019 Order, attached.

4. Due to restrictions imposed by the prison system due to COVID-19, Petitioner is unable to meet with counsel for the purposes of obtaining an affidavit of indigency. However, counsel has reviewed Petitioner's financial status, and certifies that his financial status has not changed since he was approved to proceed *in forma pauperis* in District Court. See Affidavit of Timothy Arnold, attached.

WHEREFORE, for the foregoing reasons, Petitioner respectfully requests that he be permitted to proceed in this action *in forma pauperis*.


AFFIDAVIT
