



Motion for Leave to Proceed In Forma Pauperis

The Petitioner seeks leave to file the attached Petition for A writ of Certiorari without prepayment of costs and to proceed in forma pauperis.

Petitioner was determined to be indigent in the underlying criminal proceeding and was granted leave to proceed in forma pauperis in November 2012 by the United States District Court for the District of New Hampshire in United States v. Biron, no. 12-CR-140.
