



I have suffered torture for years and pains on and off my whole life and if I deserve pain in an evil person's eyes, I went through more than I deserve. I should be released immediately and compensated for all the money and pleasures that I lost while locked up. The evidence can't be linked to me because it was all set up. It was a government and god set up. I am a hero. I saved America from 9/11 and a plane of people when we were in the air flying from Ukraine to New York. I help out good, good & evil and evil people in many ways the whole time I have been alive these 34 years. There are no witness statements linking me to the crime. Some black people, religious people and maybe other people are trying to get as many ideas out of me as they can, they might be making a fortune off of me while I'm locked up, I'm not sure if I got a fair payment for my ideas, my ideas are hella good.
