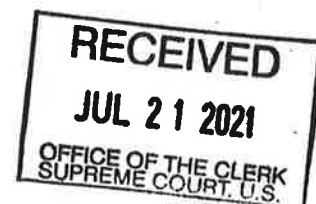

On November 27, 2019 Porter Superior Court #1 in Valparaiso, IN issued an order returning filings of the Petitioner without review and affirming all previous orders of the Trial Court (Exh. A). This order led to a direct appeal in the Indiana Court of Appeals, which ultimately affirmed this order. The Indiana Supreme Court then denied Petitioner's Petition to Transfer jurisdiction of the case (Exh. B). This led to a Petition for Writ of Certiorari currently pending before this Court.

COMES NOW Petitioner, pro se, and respectfully petitions this Honorable Court to issue a stay of the Trial Court judgment for reasons to-wit:

1. WHEREAS, without a stay, the Indiana Court of Appeals will close its file, destroying all originals and placing the file onto microfiche. This will increase the difficulty and expense of transmitting the file to this Court in the event the Petition for Writ of Certiorari is granted.
2. WHEREAS, without a stay, Petitioner will be unable to obtain an order transmitting the Trial Court file to this Court. This will disable Petitioner's ability to prove his contentions to this Court.

Additionally, this Court is the only jurisdiction able to provide the requested relief for the following reasons:


1. Porter Superior Court #1 will not accept filings from the Petitioner pursuant to an order dated 4/3/17 (Exh. C at 7).
2. The Indiana Court of Appeals has denied the requested relief (Exh. D).
3. The Indiana Supreme Court lacks jurisdiction by its own order denying transfer of jurisdiction (Exh. E).

WHEREFORE, on basis of same, Petitioner respectfully moves this

Honorable Court to issue a stay of the Trial Court judgment pending adjudication of the Petition for Writ of Certiorari.

The jurisdiction of this Court is invoked under 28 U.S.C. §2101(f).


