The petitioner asks for leave to file the attached petition for a writ of certiorari without payment of costs and to proceed in forma pauperis.


The petitioner has previously been granted leave to proceed in forma pauperis in the following courts:


DECLARATION IN SUPPORT OF
MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

I, Michael Mosley, am the petitioner in the above-entitled case. In support of my motion to proceed in forma pauperis, I state that because of my poverty, I am unable to pay the costs of this case or give security therefor; and believe I am entitled to redress.

- 1) My total monthly income is \$15.00, which is from my prison employment. I have no other income.
- 2) I have worked as a Recreation Yard Porter for the last 2 years, and get paid \$15.00 per month.
- 3) I have no cash, because inmates are not allowed to have money. I have \$241.69 in my prison commissary account.
- 4) I have no assets or items of value that I own.
- 5) No person, business or organization owes me any money.
- 6) No person relies on me for support.
- 7) I spend approximate \$10-25 per month on food and hygiene items.
- 8) I do not expect any major changes to my monthly income, expenses, assets or liabilities in the next 12 months.
- 9) I have not paid, and have no money to pay, an attorney any money for services in connection with this case.
- 10) I have not paid, and have no money to pay, anyone other than an attorney any money for services in connection with this case.
- 11) I cannot pay the costs, because I am an inmate without any support and minimal income.

I declare under penalty of perjury that the foregoing is true and correct.
