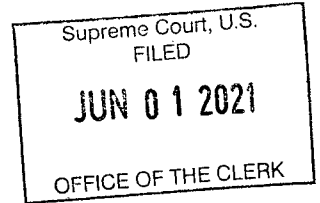

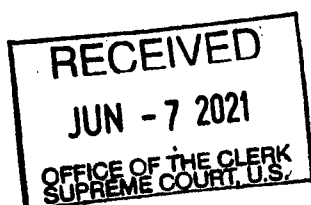



AFFIDAVIT OR DECLARATION


