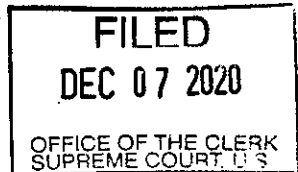


Application for permission to proceed as a poor person and for assignment of
