



DENYING PLAINTIFF'S LEAVE TO FILE A FOURTH
MOTION FOR RELIEF FROM JUDGMENT

Plaintiff, Brenda White, having submitted a Motion for Relief from Judgment to this Court, seeks leave to file the motion before the previous trial judge of record, Judge Leslie Kim Smith. Plaintiff's submission to the Chief Judge is in compliance with Judge Smith's March 21, 2019 order denying Plaintiff's Third Motion for Relief from Judgment and MCR 7.316(C)(3).

A history of the above-captioned case following the trial court's dismissal on January 14, 2014 is helpful in explaining this Court's denial of Plaintiff's leave to file a Fourth Motion for Relief from Judgment in the same case:

APPENDIX-B

On March 14, 2017, Plaintiff filed a Motion to Reinstate, which was denied by Judge Smith and Plaintiff's application for leave to appeal was denied by the Court of Appeals on June 16, 2017.

On August 15, 2017, Plaintiff filed a Motion for Relief from Judgment which was denied by Judge Smith. The Court of Appeals denied Plaintiff's application for leave to appeal and Motion for Reconsideration. On March 5, 2018, Plaintiff's application for leave to appeal was denied by the Michigan Supreme Court.

On March 26, 2018, Plaintiff refilled a renewed Motion for Relief from Judgment, which was denied once again by Judge Smith. On September 12, 2018, the Michigan Supreme Court entered an Order dismissing Plaintiff's application for leave to appeal and granting Defendant's Motion to Dismiss. Plaintiff was found to be a vexatious litigator under MCR 7.316(C)(3).

On March 11, 2019, Plaintiff filed a Motion for Relief from Judgment based upon the same allegations as the past three motions. Judge Smith denied the motion as it is without legal merit.

Plaintiff has repeatedly filed Motions for Relief from Judgment in the trial and appellate courts. All have been rejected. The present request, the fourth attempt in the same case, is vexatious and will not be permitted.

Leave to file a Fourth Motion for Relief from Judgment is Denied.



I regret the delay in responding to your inquiry. This Department receives hundreds of letters and emails each week, making some delays inevitable.

The primary responsibility of the Attorney General is to act as legal counsel for State of Michigan departments, agencies, and employees, as well as to issue opinions to members of the Legislature and department heads concerning legal issues that affect state government. These powers and responsibilities are set by law. The law does not permit the Attorney General to provide legal services to private individuals or intervene on your behalf in specific cases.

Accordingly, you may wish to contact a private attorney for advice regarding legal remedies available to you. If you need help finding an attorney in Michigan, you may contact the State Bar of Michigan's Lawyer Referral Service at its toll-free number, 1-800-968-0738. The service is available 8:30 a.m. to 4:45 p.m. Monday – Friday. For a \$25 administrative fee, a referral assistant will match you with an attorney who will provide up to a 25-minute initial consultation free of charge. Dear Ms. White:

This letter is written to stress what I indicated during our recent telephone conversation. Attorney General staff members have had numerous conversations with you over the past few years and have sent you several letters stating our position. We see no legitimate basis for our involvement in the matters you identify. As I indicated during our telephone conversation, we simply have nothing further to say.

You have asked the Attorney General to represent you and/or intervene on your behalf in several civil legal claims and administrative proceedings. You have also requested that we initiate criminal proceedings against several judges, attorneys, adverse parties, public officials and others who refuse to grant you the relief you request. We have reviewed your assertions several different times, but it is clear that there is no valid basis for us to act.

Notwithstanding my clear and unambiguous response to your prior inquiries, you continue to bombard me with recordings of your telephone conversations with various courts, administrative agencies, public officials and others. There simply isn't anything presented in those recordings which would justify any action on the part of this department.

I wish to make it clear. We have closed the files on any and all complaints you have filed and will not be taking any action. We are not now conducting any type of investigation on the matters you raised. We consider the matters at an end.
