(1) 40 PAGE LIMIT

SINCE MY CASE INVOLVED AN ACQUITTAL IN STATE COURT, A RE-INDICTMENT IN FEDERAL COURT IN WHICH BOTH WENT TO TRIAL ; IN TANDEM WITH THE FACT THAT MY ARGUMENT INVOLVES SCIENTIFIC-EXONERATING DNA EVIDENCE , I PRAY THIS COURT EXTENDS THE 40 PAGE LIMIT DUE TO THE AUTHENTICITY OF THE FACTS HEREIN.

(2) 15 PAGE REPLY BRIEF
