Many of the attorneys changed jobs, and some of the firms either merged or
changed and even some of the corporate defendants changed names or merged into
new entities.

Multiple emails were sent to multiple parties at both SHOOK HARDY &
BACON LLP (Where Mr. Darth Kadei Vaughn, was previously employed), and to

Manning & Kass, Ellrod, Ramirez, Trester LLP, where Kathleen Hunt apparently still is employed, including to the multiple emails she has/is still using, as well as the one she has posted on her **CalBar.Ca.Gov** attorney's profile site. The multiple emails to all respondents stipulated, that as a courtesy, if they chose not to respond, that **A/P Kenney** would follow the order set out by the Supreme Court, and serve them electronically due to COVID-19 contingencies. He/I, **A/P Kenney**, did so.

As has happened at every juncture of these abuses against **A/P Kenney**, he has been attacked -retaliated against- yet again many times, including: (1.) Being drugged so badly he feared for his life and had to be revived at an emergency room (~\$4,000-\$12,000 in costs stated thus far. With Health insurance. See related CA hypocrisies/ thefts, below.); (2.) Having his electronic devices hacked and harmed numerous times, by among others, both: (a.) the County of Contra Costa which for some reason is illegally stalking, harassing and harming **A/P Kenney**; & (b.) Multiple agencies and departments of Arizona, including law enforcement, DMV and AzDOT, not only hacking and blocking **A/P Kenney** from researching them, and sending emails, and hacked calls, but also having **A/P Kenney's** driver's license suspended during these Petition for Writ proceedings/timeframe. This cost enormous stress and days, if not weeks of his time, to ultimately give-up to continue this process of "petitioning"- STILL WITH NO DL; (3.) Having the state of California, which had also previously illegally "suspended" **A/P Kenney's** driver's license during the lower court and Appellate stages, which cost **A/P Kenney** several days of stress and persuading the state of California it wasn't a "banana republic" that just *ad hoc* stole people's licenses.
