I represent petitioners in the above-captioned matter. On February 2, respondent Irving H. Picard filed a waiver of his right to respond to petitioners' petition for a writ of certiorari; on February 3, respondent Securities Investor Protection Corporation filed a similar waiver. I write to inform the Court that the Securities Industry and Financial Markets Association and ABN AMRO Retained Custodial Services (Ireland) Limited have each committed to file amicus briefs in support of the petition on or before March 2, unless the Court calls for a response to the petition before that date (thereby extending the deadline for briefs of amici curiae).
