**ORDER OF
GRIEVANCE PANEL**

(Filed Feb. 4, 2022)

Jack R.T. Jordan, a member of this Court's bar, has notified this Court of his disbarment by the United States Court of Appeals for the Eighth Circuit and requests, inter alia, that this Court not reciprocally disbar him based on the Eighth Circuit's disbarment order. We note that Jordan has expressed an intention to appeal the Eighth Circuit decision to the Supreme Court and has been granted an extension of time to file a petition for writ of certiorari. *See Campo v. Department of Justice*, S. Ct. No. 21A358, 1/27/2022 order (granting until 4/1/2022 to file certiorari petition).

Upon due consideration, it is hereby **ORDERED** that this reciprocal disciplinary proceeding is **STAYED** pending further notice of this panel. It is further **ORDERED** (a) aside from any appeals in this Court in which Jordan is currently an attorney of record, Jordan not appear or represent any clients before this Court unless he is first granted leave to do so by this panel; (b) Jordan notify this panel of all future decisions of the Supreme Court in, or resulting from, the proceeding docketed in that Court under 21A358; and (c) Jordan notify this Court, within 28 days of the date of the present order, whether he is the subject of any pending disciplinary proceeding before any disciplinary authority, including a disciplinary committee of the New York Appellate Division, and, if so, provide a copy of the disciplinary charges, all responsive papers, and all orders relating to those charges. Jordan must update his response to clause (c) of this paragraph if any disciplinary proceeding is initiated after the 28-day period.

The Clerk of Court is directed to serve a copy of this order on Jordan and all courts and jurisdictions to which this Court distributes disciplinary decisions in the ordinary course.
