Dear Mr. Harris:

The petition in the above-captioned matter was filed on April 19, 2022 and placed on the Court's docket on April 21, 2022. On June 14, 2022, the Court granted an extension of time to file a response, to and including July 21, 2022. Pursuant to Supreme Court Rules 15.3 and 30.4, respondent hereby respectfully requests a further twenty-one (21) day extension of time, to and including August 11, 2022, in which to file its brief in opposition. This request would not delay consideration of the petition, which, under the Court's case distribution schedule, would still be considered at the Justices' September 28, 2022 conference.

The extension is necessary because of the press of other matters, including an amicus brief in *Juno Therapeutics, Inc. v. Kite Pharma, Inc.*, No. 21-1566, due in this Court on July 15, 2022; a response to a petition for rehearing in *U.S. ex rel. Vermont National Telephone Co. v. Northstar Wireless, LLC*, No. 21-7039, due in the D.C. Circuit on July 21, 2022; an oral argument in *Mylan Pharmaceuticals Inc. v. Merck Sharp & Dohme Corp.*, No. 21-2121, scheduled before the Federal Circuit on August 2, 2022; a reply brief in support of summary judgment in *Trinka v. McDonough*, No. 21-cv-2904, due in the District Court for the District of Columbia on August 4, 2022; a response brief in *National Pork Producers Council v. Ross*, No. 21-468, due in this Court on August 8, 2022; and a principal brief in *Kim Martinez v. ZoomInfo Technologies, Inc.*, No. 22-35305, due in the Ninth Circuit on August 12, 2022.

Counsel for petitioner has been informed of this request and stated that petitioner does not object to an extension to and including August 11, 2022.
