**PETITION FOR REHEARING**

TO THE HONORABLE SUPREME COURT OF THE UNITED STATES OF AMERICA:

There is no right to trial by jury in any type of civil case in Puerto Rico; therefore, people have no representation in civil case trials. Puerto Rico is the only jurisdiction under the American flag where only bench trials occur.

On the other hand, criminal cases in Puerto Rico are tried by jury, since the Honorable Supreme Court of the United States ruled that the Constitution of Puerto Rico was created by legislation of Congress; and, therefore, trials in criminal cases must be governed by the United States Constitution.

New jurisprudence is needed by this Honorable Supreme Court of the United States to eradicate and abolish the inequity of the lack of jury trials in civil cases.
