Dear Madam/Sir:

The undersigned firm represents Respondent Hillsborough County Civil Service Board¹ (HCCSB) in its response to the Petition for Writ of Certiorari filed by Petitioner Jacquelyn Bouazizi and currently before this Court. Pursuant to Rule 30.4 of the Rules of the Supreme Court of the United States, HCCSB respectfully requests that the time period for filing a response in opposition to the Petition for Writ of Certiorari be briefly extended for seven (7) days, up to and including December 6, 2021. This request is necessary for the following reasons:

HCCSB's response is currently due on November 29, 2021. This extension is being sought ten days prior to the deadline.

The current deadline for the brief falls on the Monday following the Thanksgiving holiday. The offices of counsel for HCCSB are closed on Thursday, November 25, and Friday, November 26, 2021 for the holiday. Additionally, in light of the holiday, administrative support is currently short-staffed, which will affect the capacity of counsel to prepare the necessary copies for filing.

Accordingly, HCCSB respectfully requests that the time in which HCCSB may respond to the Petition for Writ of Certiorari be briefly extended to and including December 6, 2021.




