## MOTION FOR LEAVE TO DISPENSE WITH PREPARATION OF A JOINT APPENDIX

Pursuant to Supreme Court Rule 26.8, petitioners respectfully seek leave to dispense with the requirement of a joint appendix in this case. Respondents agree that a joint appendix is not necessary and concur in the filing of this motion.

The case presents two questions involving the dormant Commerce Clause. These questions arise from the grant and affirmance of respondents' motions to dismiss petitioners' claims and for judgment on the pleadings. The record is therefore limited. The appendices to the petition for writ of certiorari include all relevant lower court opinions and orders, the challenged state law and initial proposed regulations implementing that law, and the complaint and supporting exhibits. An appendix to the reply brief includes the revised and most recent proposed regulations. In our view, no other portion of the record merits special attention such as would warrant the preparation and expense of a joint appendix, and preparation of a joint appendix would not materially assist the Court's consideration of the case.

We are authorized to state that counsel for the respondents agree that a joint appendix is not necessary.
