**RE: INITIATING IMPEACHMENT PROCEEDINGS AGAINST U.S. SUPREME COURT JUSTICE SAMUEL ALITO**

Pursuant *U.S. Const. Article I Sec. 2, Clause 5* and *3 Hinds Sec. Sec. 2364, 2491, 2494 I*, Zoe Ajjahnon, representing the LOI Network, Inc., hereby Petition for the Impeachment of Justice Samuel Alito. The enclosed Oct. 18, 2021 brief to the U.S. Supreme Court will serve as substantiation of the Articles of Impeachment regarding the indicated constitutional responsibility to remove Justice Alito from the bench.

I represent the LOI Network in this call for Justice Alito' impeachment.
