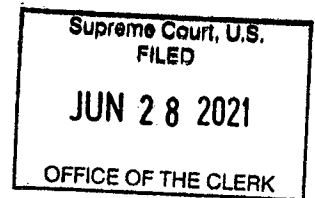

I lost my full-time retail job due to COVID-19, and I am fortunate to be receiving unemployment benefits while I continue looking for work. However, as you can see, those benefits cover only slightly more than my monthly minimum payments, and the rest goes to unexpected expenses that arise, such as car repairs, and paying off credit card debt.

Moreover, I currently owe \$504,871.53 in student loan debt (interest accrues) and \$135,300.78 in consumer debt, both of which I am unable to service. In light of the above, I respectfully ask that this Court grant this application.
