

## QUESTIONS PRESENTED

Technological advancement in the 21<sup>st</sup> century has led to an innovation (involving supply chain technology and a novel form of payment processing) allowing for outstanding wealth creation capacity on one hand, and an electronic weapons system with cerebral engagement capabilities on the other. The latter is being used by Mr. Biden in an attempt to unlawfully take the former from the Petitioner. In addition, statutory rights of access to capital are being unconstitutionally withheld from the Petitioner by the Respondents. Moreover, Mr. Biden has abandoned his Article II duties by supporting the interests of Russian President Vladimir Putin for personal financial gain. The questions presented are as follows:

1. Did the United States Small Business Administration fail to complete its statutory duty by arbitrarily avoiding the issuance of an Economic Injury Disaster Loan (EIDL) to Petitioner's business, Pricecheck Inc.?
2. Granted verifiable facts and clear and convincing evidence of treason done by Mr. Biden, does the Court, in advance of an impeachment trial by Congress, have the authority to issue orders, to all necessary executive departments and agencies, in the name of the President in order to prevent further harm to the United States and to immediately ensure national security?

3. Does the Presidential Power of Authorization for Use of Military Force, or any other Executive power, include the authority to use electronic weapons against the persons and properties of United States civilians, without justifiable cause, even in the interest of an attempt to avoid the very substantial cost of a lawful taking?

## I. JURISDICTION

The jurisdiction of this Court is invoked under 28 U.S.C. 1651.

## II. STATEMENT

### *A. Introduction*

The facts of this case concern also, what is believed to be a far more widespread abuse of power involving electronic weapons. For this reason it is important also to accept the urgent nature of this petition.

In this case, the Petitioner's demand for justice concerning his person and property has been followed by unconstitutional surveillance, intimidation tactics, and large scale tampering ranging from tampering with Petitioner's financial concerns held with financial institutions including M&T Bank, to tampering with Petitioner's business records held by the Internal Revenue Service. The nature of this activity is reasonably determined to be of a scope and scale recognizable as espionage. Moreover, Mr. Biden's refusal to address this urgent concern administratively, reflects complicity and treason.


The capabilities of the electronic weapons to be described in more detail below, allow for exploits by means of intimidation, and internal steering of the otherwise integral exercise of public or private fiduciary duty, that continues to result in, what should be, unimaginable harm to the American people.

The explanation I am about to provide was probably considered too complicated to share in a way that anyone could understand and that's what has made it so powerful but all we need is a light in this darkness to clear the air.

Technology as we know it comes from some bright ideas as ways to improve the things that we already have. For this example, we'll need to consider some things you probably already know about and that you have an understanding of how they work. Perhaps you've heard of the groundbreaking technology Neuralink, it's a link to your brain that lets you control things like video games for instance. To get a grip on how that works, it's important to remember that our brains and bodies work together using electrical signals. For instance, as I type this paragraph, my brain is sending electrical signals to my hands and that signal tells my hands where and how to move. In case you aren't sure about that, consider how prosthetics work. There are sensors inside those devices that pick up the signals from the nerve endings of patients using those devices and allows for amazing results like the function of a hand by way of the same electrical signals from the brain that the patient would normally use.

## B. Privacy Invasive Nanotechnology

The thalamus, or the sensory switchboard of the brain, among other regions, controls all of your movement and your thoughts and just about everything inside your brain. Accordingly, reading those signals has been made possible by a device like Neuralink where the signals can be translated into ones and zeros as computer language and can then act as an input output medium between computers and human brains. That sounds cool in appropriate application and with consent and understanding but the problem we face today has to do with lack of consent.



The more commonly known implementation of the technology involves surgery. For instance on June 23, 2011, the Department of Electrical Engineering & Computer Science, McGovern Institute for Brain Research, Media Lab, Department of Brain and

Cognitive Sciences, and the Department of Biological Engineering at MIT published research entitled “A Wirelessly Powered and Controlled Device for Optical Neural Control of Freely-Behaving Animals” where such an experiment had been successfully developed to control the mind and function of a rodent.

However, so-called “non-invasive” versions have been developed to be capable of introducing the technology to the human body without a person's knowledge and consent. While there are a variety of formulations allowing for such a result, the two described here are an advanced methodology for transcranial direct current stimulation (tDCS) not involving electrodes placed directly on the scalp, and Near Infrared Light Activatable Nanoparticles for Deep Tissue Penetrating Wireless Optogenetics. The former being wirelessly engaged without any direct contact with the person and the latter involving an electroceutical injection that is as simple as getting a shot.


In October 2016, the U.S. National Institutes of Health (NIH) funded electroceutical research for the development of tools for electrically stimulating the nervous system.<sup>1</sup> In addition private technology and pharmaceutical companies have also aggressively instituted research to advance the industry.

### BUGGING THE BRAIN

An interdisciplinary team has created a rolled mesh of electronics that can be injected into a mouse skull. Once there, it unfurls and melds with the brain tissue.



On April 12, 2017 the online neuroscience magazine IEEE Spectrum produced an article detailing the variety of advancement in the industry. As described there, “Charles Lieber ... a Harvard professor of chemistry and engineering, and [Guosong] Hong, one of his postdocs, [were] developing an “electronic mesh” that is injected by syringe into the brain tissue, where it unfurls to make contact with many neurons.”<sup>2</sup>

On January 11, 2019 Ovid Technologies, Inc. published research done by Wiley Verlag GmbH & Co. regarding state of the art Near Infrared Light Activatable nanoparticles for Deep Tissue Penetrating Wireless Optogenetics. “These NIR-activatable optogenetic tools enable low-invasive “remote control” activation and inhibition of cellular signaling pathways.”<sup>3</sup>

### *C. The Intersect Between Electroceuticals and Mobile Phone Towers*

In the Emerging Communication Technologies for 5G-Enabled Internet of Things Applications from Springer Link scientific journal, the abstract reveals the following, in part:

“The Internet of Things (IoT) is quickly spreading, arriving at ... personal health care .... It has the potential to provide unified, efficient machine to human and machine to machine (M2M) communication and connectivity.... 5G wireless technologies have become the most challenging and exciting topic in IoT as they [are] game-changers in the [present] generation.”<sup>4</sup> Accordingly, the transmission of data from human minds to computers and then on to other human minds is completed by way of mobile phone towers.

“On October 18, 2018, a team of researchers from ETH Zurich, the University of Lorraine and the University of Dundee released a paper entitled, “A Formal Analysis of 5G Authentication”<sup>5</sup>. It alerted that 5G technology could

open ground for a new era of security threats. The paper described the technology as "immature and insufficiently tested," and one that "enables the movement and access of vastly higher quantities of data, and thus broadens attack surfaces". Simultaneously, network security companies such as Fortinet<sup>6</sup>, Arbor Networks<sup>7</sup>, A10 Networks<sup>8</sup>, and Voxility<sup>9</sup> advised on personalized and mixed security deployments against massive DDoS attacks foreseen after 5G deployment."<sup>10</sup>

“On January 23, 2020 the service provider MTS Belarus launched test zones, with Huawei and Cisco equipment, of a 5G NSA network in Minsk.”

“On May 22, 2020 A1, in partnership with ZTE, launched the first 5G SA network in Belarus, in test mode, in Minsk,<sup>11</sup> and on May 25 it made the first call in the CIS<sup>12</sup> by means of VoNR (Voice over New Radio) technology for the 5G burst transmission of voice.”

#### *D. Political and Personal History*

“In 1968, Biden earned a Juris Doctor from Syracuse University College of Law, ranked 76th in his class of 85,

Mr. Biden was “elected to the Senate in 1972, Biden was reelected in 1978, 1984, 1990, 1996, 2002, and 2008.”<sup>14</sup>

“Biden formally declared his candidacy for the 1988 Democratic presidential nomination on June 9, 1987.”<sup>15</sup> He raised more in the first quarter of 1987 than any other candidate.”<sup>16</sup> During the campaign he made “several false or exaggerated claims about his early life.”<sup>17</sup>

“[O]n September 23, 1987, Biden withdrew from the race, saying his candidacy had been overrun by ... past mistakes.”

“In February 1988, after several episodes of increasingly severe neck pain, Biden was taken by ambulance to Walter Reed Army Medical Center for surgery to correct a leaking intracranial berry aneurysm. While recuperating, he suffered a pulmonary embolism, a serious complication. After a second aneurysm was surgically repaired in May, Biden's recuperation kept him away from the Senate for seven months.”

“In a 1974 interview, he described himself as ... conservative on other issues, including abortion and military conscription.”<sup>18</sup> There is no current enforced conscription in the United States. “Conscription (sometimes called

the draft in the United States is the mandatory enlistment of people in a national service, most often a military service.”

“Biden met Soviet Foreign Minister Andrei Gromyko [in 1979] to communicate American concerns and [secure] changes that addressed the Senate Foreign Relations Committee's objections” after a failed agreement in Congress.<sup>19</sup>

“Biden was a longtime member of the Senate Foreign Relations Committee. He became its ranking minority member in 1997 and chaired it from June 2001 to 2003 and 2007 to 2009”<sup>20</sup> “During this time he met with at least 150 leaders from 60 countries and international organizations, becoming a well-known ... voice on foreign policy.”

“Biden voted against authorization for the Gulf War in 1991,” ... he became interested in military engagement in the Balkan region while the “The George H.W. Bush administration and Clinton administration were both reluctant to implement the policy, fearing Balkan entanglement.”

In April 1993, Biden spent a week in the Balkans and held a tense three-hour meeting with Serbian leader Slobodan Milosevic.” Taking a look back to 1987, the same year Biden raised more money than any other candidate in his campaign for President, “Milosevic emerged in 1987 as a force in Serbian politics as the 8<sup>th</sup> Plenary Session of the League of Communists of Serbia on September 22, 1987,”<sup>21</sup> the day before Biden dropped out of his 1988 Presidential campaign.

“As head of the Senate Foreign Relations Committee, he said in 2002 that Iraqi president Saddam Hussein was a threat to national security and there was no other option than to "eliminate" that threat.”<sup>22</sup> In October 2002, he voted in favor of the Authorization for Use of Military Force against Iraq, approving the U.S. invasion of Iraq.

He supported the appropriations for the occupation, but argued that the war should be internationalized, that more soldiers were needed, and that the Bush administration should "level with the American people" about its cost and length.<sup>23</sup>

"Biden had difficulty raising funds, struggled to draw people to his rallies, and failed to gain traction against the high-profile candidacies of Obama and Senator Hillary Clinton"<sup>24</sup> He never rose above single digits in national polls...."<sup>25</sup>

Biden was able to leverage his foreign policy and national security experience,<sup>26</sup> to appear as a necessary running mate to Democratic nominee Barack Obama,<sup>27</sup> despite

offhand remarks that attracted negative attention<sup>28</sup>. “Obama campaign staffers referred to Biden blunders as “Joe Bombs” and kept Biden uninformed about strategic discussions.”<sup>29</sup> According to the Pew Research Center’s Project for Excellence in Journalism, “Biden’s vice-presidential campaigning gained little media visibility [as] ... Biden was included in only 5% of coverage of the race.”<sup>30</sup>

“Biden was officially nominated for vice president by voice vote at the on August 27<sup>th</sup> 2008 by voice vote at the 2008 Democratic National Convention in Denver.”<sup>31</sup>

Weeks later, “with the bankruptcy of Lehman Brothers on September 15, 2008 and a subsequent international banking crisis, financial institutions worldwide suffered severe damage.” Years later it became apparent that “...the worst performing mortgages were funded through the “shadow banking system” and that competition from the shadow banking system ... pressured more traditional institutions to lower their underwriting standards

### *E. Biden's Longstanding Interest in Scientific Researchers*

Charles Lieber, the Principal Investigator of the grant funded research involving electronic mesh has a closely related historical timeline of scientific achievements that directly correlate with Biden's political agenda.

“Charles M. Lieber was born in Philadelphia, Pennsylvania in 1959. He attended Franklin and Marshall College for his undergraduate education and graduated with honors in Chemistry. After doctoral studies at Stanford University and postdoctoral research at the California Institute of Technology, he moved to the East Coast in 1987 to assume the position of Assistant Professor at Columbia University. Here Lieber embarked upon a new research program addressing the synthesis and properties of low-dimensional materials. He moved to Harvard University in 1991 and holds a joint appointment in the Department of Chemistry and Chemical Biology and the Harvard John A. Paulson School of Engineering and Applied Sciences, as the Joshua and Beth Friedman University Professor. He also serves as the Chair of the Department of Chemistry and Chemical Biology. Lieber has been a pioneer in nanoscience and nanotechnology where he has originated new paradigms that have defined the rational growth, characterization, and original applications of functional nanometer diameter wires and heterostruc-

tures. Lieber has provided seminal concepts central to the bottom-up paradigm of nanoscience, and has been a leader in defining directions and demonstrating applications of nanomaterials in areas ranging from electronics, computing, and photonics, as well as pioneering the interface between electronics with biology and medicine, including his current focus in brain science....

Lieber has published over 400 papers in peer-reviewed journals and is the principal inventor on more than 50 patents. In his spare time, Lieber has been active in commercializing nanotechnology, and founded the nanotechnology company Nanosys, Inc. in 2001 and the new nanosensor company Vista Therapeutics in 2007.”<sup>36</sup>

Lieber was arrested on Jan. 28, 2020, and charged by criminal complaint. The U.S. Department of Justice Published statement on Tuesday, June 9, 2020.<sup>37</sup>

In March 2016, Mr. Powell had an idea: A mobile shopping application that would allow retail customers to walk into physical stores, scan items using their smartphone cameras, and checkout right on their phones.

Mr. Powell began prospecting the self-checkout market opportunity starting with the National Retail Federation’s (NRF) Top 250 Global Retailers listing by order of consolidate global sales figures. Walmart topped the list with \$435 billion in 2015. He understood then that if 10%

of shoppers paid a 1% transaction fee for a self-checkout convenience service at Walmart stores in 2015, then the provider of that service would have created \$435 million of revenue from that one merchant customer.

Mr. Powell was unable to identify any competitors using mobile phones for 'cashierless' checkout when conducting an internet search for such a finding at the time. He began to adopt a vision and passion for developing a suitable product of this capability and thereby establishing a profitable business.

Another top retailer on the NRF list that year was No. 11, E-Mart: headquartered in Seoul, south Korea having had \$110 billion in sales 2015. Mr. Powell made plans to visit and attract the business of E-Mart. He also made every effort to safeguard his growing market intelligence.

For further details, see the attached Draft Amended Complaint, comprising all of the details regarding Mr. Powell's antitrust litigation against Alphabet Inc. in April 2019, following the January 2019 scientific publication by Ovid Technologies and Mr. Biden's February/March 2019 announcements of his candidacy for president. The suit was dismissed due to behavior that was inconsistent with the otherwise integral exercise of public and private fiduciary duty.

#### *F. U.S. Russia-Relations Panel*

Prior to his presidential campaign, Mr. Biden participated in the Council on Foreign Relations' panel on U.S.-Russia Relations with experts Carpenter and Haas. During the panel, Mr. Biden aroused the suspicions of the audience with a number of, what appear to be, unintentional revelations about his true intentions and ambitions. For instance at one point he said. "I don't want to acknowledge you guys are spying on the intelligence agencies."<sup>38</sup>

After a question about U.S.-Russia relations concerning the Middle East, Mr. Biden says at one point that we are going to see troop drawdowns in the region. At one point he says, again seemingly unintentionally, that Russia has a tiger by the tail and we're going to let them have it. This begs the question: Who's the tiger? <sup>39</sup>

As described in reporting by Vice News and Wired Magazine, a Google/Alphabet subsidiary named Jigsaw began paying for disinformation campaigns run by Russian hackers.

Google founder Sergey Brin also happens to be a Russian immigrant who moved to the U.S. as a child, where his father, a mathematician, worked at Maryland University. "[In early 2018,] Jigsaw [a Google subsidiary] re-

searchers and a security firm they partnered with paid \$250 to a Russian organization that specializes in disinformation campaigns. Jigsaw then created a site with fake content criticizing Joseph Stalin, and the Russian troll services company launched a two-week disinformation campaign on Twitter, forums, and via fake sites to attack the phony sites' agenda. The purpose of the experiment was nominally to show how easily online disinformation campaigns can be set up, Critics lambasted the experiment, in which Jigsaw paid for a Russian troll army to orchestrate a disinformation campaign. For some, this was a misguided attempt to document the problem of disinformation and fake news.”

Around this time, December 2017, (just prior to the U.S.-Russia Relations panel), Mr. Powell noticed something strange that he had never seen before. The first page that came up in a Google search for Pricecheck was a TechCrunch article about Amazon's Pricecheck App from 2010. Mr. Powell was annoyed and confused by it. He was certain he had checked everywhere on the web and remembers finding nothing related to Pricecheck in his initial market research. However, something he did not notice at the time but later verified the legitimacy of this article, was that the trademarks/logos from LinkedIn and Twitter are from around 2017, in this 2010 article archive. A legitimate article from 2010 shows the older versions. A second article supposedly from the same period and it mentions Mr. Powell's birthdate “December 24”, and uses a very similar check mark as to Pricecheck's pending trademark registration in order to

discredit Pricecheck and Mr. Powell and pointedly jest underhandedly about his life and his business, and to make his intellectual property look like a copy, when the opposite is the truth. See pg. 57 of the draft amended complaint for image attachments and more details.

In response to a question about the motivation for the state of affairs and why things are the way that they, Biden responds by saying “[t]his is all designed to protect vast amounts of wealth and vast amounts of corruption.” After the natural confusion tension in the room about the next begged question to arise in any reasonable mind: ‘what has been designed?’ Haass makes an uncomfortable joke by saying “[t]his meeting continues to be on the record, so you’ve just been read your Miranda rights.”<sup>40</sup>

The most concerning part of the discussion arose in Biden’s description about tactics and methodology where he says: “We are not going to be able to hold the rest of Europe, on these sanctions, and Russia is not going to roll across the inter-line here and take over the rest of the country with their tanks, what they’re going to do is take your economy down, you’re gonna be absolutely buried, and you’re gonna be done, and that’s when it all goes to hell, and to the best of my knowledge, and I have ... (*long pause, and sigh*) ... it’s a very difficult spot to be in now..I..”<sup>41</sup>

He goes on to say: “I'll give you one concrete example, I, I was, not I, I but it just happened to be, that was the assignment I got, I got all the good ones, uh, so I got Ukraine, um I remember going over convincing our team, our-or others to be convincing that ....”<sup>42</sup> The repeated admissions of involvement in corruption appears evident to others on and off the panel, for instance the other panelist Michael Carpenter and a woman from the audience have apparent suspicions and concerns.


Towards the end of the discussion Mr. Carpenter says with a stare at the height of his suspicion that: “We're going to see the low boil, we're going to see, more importantly, the dirty money flowing into Kiev, and they've got elections coming up in 2019” .... Biden, showing body language that he realizes Carpenter and others are on to him and his scheme, says close to his final words on the panel: “I'm not going to live this down.”

Afterwards in discussions with members of the audience that are not audible amidst the noise of the crowd, a 0.5x speed review and and lip reading of Joe Biden and a woman in magenta shows that people confront him about the plans he has, using what must be some kind of communication technology. The lady says at one point: “I know what's going on.” “You said it twice.”






Biden: "This is going to blow over"

Biden responds first by touching the woman's face romantically, she is visually offended as are others, he continues by touching her face again as if to kiss her. ### III. Reasons for Granting the Petition

#### A. Petition of National Importance

The extraordinary nature of this circumstance is of national importance. The petition does not seek the power of the Court on a lower court matter, but rather seeks urgent action to address the concerns of similarly situated individuals and entities held hostage in internally under similar ransom seeking activity, using actual and attempted physical and psychological controls by Mr. Biden's foreign-directed co-conspirators.

#### B. Article II AUMF Powers are Limited by the Fourth Amendment
