



Appellant timely filed a petition for rehearing on December 3, 2020, and the petition for rehearing was denied on February 1, 2021. The Order denying rehearing terminated these proceedings.

No motion or application for rehearing or review will be accepted for filing after the denial of a petition for rehearing. Okla. Sup. Ct. Rule 1.13 (e). Appellant's second petition for hearing, filed on February 26, 2021, will not be considered, and any future filings by appellant in this cause will not be considered.
