




The money on my inmate account came from the COVID-19 stimulus checks and money provided as a loan per an agreement with Barbara Dew. The money from Barbara Dew represents a liability and not an asset.

In addition, I owe an outstanding balance of over \$150,000.00 to Barbara Dew for loan assistance for prior legal fees. I also owe over \$60,000.00 in student loans. I apologize for not being able to pay the costs of this case.




Dear Clerk of Courts:
