The lower courts overlooked The plaintiff's statement on why this appeal should go forward. The lower courts never reviewed the logging of ~~EXHIBIT~~ # "777" an MP3 Flash drive containing usable information (Facebook Post) for the last 10 years with evidence that clearly points the plaintiff's Facebook page was hacked in 2018 and when plaintiff reported it to the FCC was only then the plaintiff got a new password from Facebook. When plaintiff got his page back 1 month's of information was missing from July 2016 to November 2016.

The page was missing 4 months of data that was used to produce CBS Television show "100 Friends me" Plaintiff ask the court for 500,000.00 (Five Hundred Million For Compensation)

CONCLUSION

A material point of fact or law was overlooked in the decision by the Lower courts. Lower court judges failed to look at Exhibit # "888" MP3 Flash Drive Evidence

The petition for a writ of certiorari should be granted.
