**MEMORANDUM OPINION
 BY JUDGE SIMPSON**

FILED: December 17, 2019

After repeated appeals and prior adjudications in this prolonged human services case, Steven Burda (Applicant), representing himself, petitions for review of a final order of the Department of Human Services (Department), Bureau of Hearings and Appeals (BHA). Therein, the BHA affirmed an Administrative Law Judge's (ALJ) order denying his appeals from two Montgomery County Assistance Office (CAO) decisions. Specifically, Applicant appealed the CAO notices discontinuing both Supplemental Nutrition Assistance Program (SNAP) benefits² for Applicant and his family,³ and Medical Assistance (MA) benefits for Applicant, his wife, A.B. (Wife), and his daughter, C.B. (Daughter), when their household income exceeded eligibility limits. Discerning no error below, we affirm.

¹ This matter was assigned to this panel before September 1, 2019, when Judge Simpson assumed the status of senior judge.

² SNAP benefits were formerly known as "Food Stamps." 7 U.S.C. §§2011-2036c.

³ Applicant's five-person household includes infant twins, I.B. and Z.B., who continue to receive Medical Assistance (MA) benefits. The twins' benefits are not at issue in this appeal.
