## **CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED**

### RACKETEER INFLUENCED AND CORRUPT ORGANIZATION ACT (RICO) SECTION 1341 & 1343

The racketeer influence and corrupt organizations act is a united states federal law that provides for extended criminal penalties and a civil cause of action for acts performed as part of an ongoing criminal organization.

### These are elements of the RICO ACT of 1970

① That the enterprise existed; (2) that the enterprise affected interstate commerce; (3) that the defendant was associated with or employed by the enterprise; (4) that the defendant engaged

### ② 18 U.S. CODE § 1341 - Frauds and Swindles

Elements ① Whoever, having devised or intending to devise any scheme or artifice to defraud, or for obtaining money or property by means of false or fraudulent pretenses, representations, or promises, or to sell, dispose of, loan, exchange, alter, give away, distribute, supply or furnish or procure for unlawful use,

### ③ 18 U.S. CODE § 1343 Fraud by wire, radio, OR TELEVISION ELEMENTS

means of false or fraudulent pretense, representation, or promises, transmits or causes to be transmitted by means of wire, radio, or television communication in interstate or foreign commerce.

The defendant's listed Brought the plaintiff's product to a standstill for around 24 days with no bargaining or exchange. These Judges Silverman, WATFORD and Bennett needs to be investigated for Judicial misconduct for violation "under the color of Law". By the United STATES Attorney general for Bribery by the defendant's Counsel or by the defendant himself.

② Under Color of Law - These Three Judges violated the plaintiff's Constitutional Rights 18 USC 242 Section 242 provides in event PART "Whoever, under color of any law...willfully subjects any person... to the deprivation of any rights, privileges or immunities secured or protected by the Constitution or laws of the United States [Shall be guilty of a crime. I tried reaching out to Facebook technical Support Team for almost a month with no help from them. There was no 1-800 number to call so I reported it to the F.C.C. When I finally got my Facebook page back after being hacked over a month I noticed that 4 months of data in my post were deleted. The data was missing from July 2016 to November 2016. Among data / posts were the one where I prophesied about my late dear mother entering The SHEKINAH GLORY REALM caught on video and witnessed by over 4,000 friends, family and Facebook Technicians. I had about a dozen Facebook Tech's and Employees who also witnessed this event.

② This Event showed an Angel ascension into the clouds also witnessed by many of social media. I pressed save on it but it so far has not come up on my page or memory history that Facebook reminds you of your yearly memories. I have a 9-year Documentary with Facebook and it has breached its agreement to keep people's page secure. Also on my mother's first anniversary of her death I testified about a dream I had many, many years ago where I was in this Olympic size pool where there was nothing but brightness and I was in the pool. I could see a long silky robe / gown that was clear see-through with crystals in it. I couldn't see a face because the brightness but you could tell it was out of the pool but the garment was in the pool. It led from out the pool into the pool and I touched it and felt the Holy Spirit. It's a great feeling that I experienced when I first got save. It's a supernatural feeling of the presence of God. A lot of my friends remember the post and I had told family and friends before I even went public. I believe Facebook sold my story to the highest bidder on the black market. I would like to be compensated for emotional stress and depression. This is detrimental because a lot of family history, codes and pyramids been removed from my page. Also missing on my page is a history of Allen's profiles and a lot of information on UFO's (Eastern Starships) and footage of live aliens.

③ Also my Guardian Angel (my mother) #667 Facebook friend was removed from my page along with her profile and pictures in Paradise. This is truth to what I'm saying Your Honor, and I know this is the right court, The United States District Court for the Eastern District of California to use resources to investigate this violation of wiretapping, hacking to a foreign country, Russia Soviet Union to violate the RICO Act (1970) 18 U. S. C.

This complaint has established subject matter and this complaint falls under Federal Jurisdiction. All Defendants were involved in a Federal probe with the Cambridge Analytica Scandal in which my private Facebook page Donnell Music Donjuan Bledsoe (original page) got hacked.

Last but not least you have 9 similarities (not coincidence) and are facts.

- 1) Miles's ex-girlfriend or sister's name is Mia. Well, Your Honor, my ex-deceased wife's name is Mia.
- 2) Mills (main character) uses a blue cell phone just like mine on my Facebook page Donnell Bledsoe (Music Donjuan). I took a picture in a brown plaid shirt shown on my 9-year documentary. - 3) Mills is called the prodigal child (prophet). I'm called God's Child Spiritual Analyst #1 VIRGO 777 \*\*\*\*\* King of the South 33° Degrees \*\*\*\*\* Music Donjuan Bledsoe. I am a fourth generation Eastern Star. My mother's maiden name is Pearly Beatrice McClellan A.K.A. Pearly Beatrice Lauder. My mother Pearly Beatrice Lauder is listed on the 1983 Roster of Grand Officers at the 1983 Annual Grand Session in Oakland, California as the Grand Queen Matron (Queen of the South) M.W.M.T. NEBO Grand Lodge, A.F. & A.M. of Oakland, California, Queen Esther Grand Chapter. O.E.S. Sister Ella Mae Dean (Maiden name Ella Mae McClellan after her grandmother) M.W.G.M., sister Olena, A.G.M. III. Willie Burns, M.W.G.P., III, Charlie Clalborne, A.G.P. and that is how I inherited the King of the South through Bloodline. I am a prophet; my name Donnell actually means Daniel and Daniel stands for the number eleven and it also stands for Egypt.
- 4) Mills doesn't believe in God; he is an anti-Christ. Anti-Christ don't believe in God. I don't believe in Christ but I believe in god "Osiris" ancient African God of the advance civilization (Eastern Starships or UFO's). See Exhibit 17 of a live Eastern Starship (U.F.O.) on my page that I personally. See Coming Back from Moonstone Beach. See,

5) God contacted Mills through his Facebook account and my mother Facebook Friend #667 contacted me also on my Facebook page.

6) His god account from Facebook got hacked. Well, Your Honor, my private Facebook account A.K.A. "God Child Spiritus Analyst" also got hacked and I, the Plaintiff, reported it to the FCC and to Facebook with no help from Facebook, a Delaware Corporation or Mark Zuckerberg CEO of Facebook. Independent Analyst informed that the hackers were from the Soviet Union Russia and were going to charge me an excessive amount of money to recover my account. Later on, I found out about the Cambridge Analytica Scandal which falls under the RICO Act (organized crime Act of 1970) 18 U.S.C. This was an illegal transfer of data through the Internet all the way to the Soviet Union Russia which makes this a Federal matter because it was transmitted via wire hacked/stolen from rightful owner Plaintiff Donnell Bledsoe Sr., F.B. The United States District Court for the Eastern District of California has the authority and jurisdiction to investigate the master hard drives of Facebook, a Delaware Corporation and Mark Zuckerberg Facebook Headquarters at 1 Hacker Way, Menlo Park California 94025. (855)910-2001.
- 10) Another fact on how the Defendants Mark Zuckerberg CEO of Facebook and Facebook, a Delaware Corporation Breach Contract and violated the RICO Act of (1970) 18 U.S.C. is the Plaintiff Donnell Bledsoe Facebook page Exhibit 888. Donnell Bledsoe (Music Donjuan) Facebook private page is when the Defendants illegally electronically hacked the Plaintiff's Documentary; story, pictures and ideas. Basically hacked 4 months of data. Scandal where it was sold to the highest bidder CBS "God Friended Me" show. Brandon Michael Hall, the main character Mills gets paid 1.2 million for the show putting it over 75,000.00.
