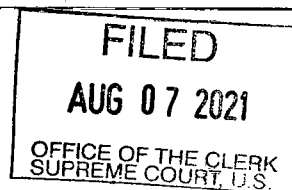

## STATEMENT OF THE CASE

Petitioner receives her mail at a day center for homeless women and has had to file a criminal complaint with the U.S. postal Service and Inspector General because an employee at the Gathering Place most likely stole her mail.

Petitioner[s] I.D. was sold to Mexican traffickers from a day center for the homeless in Portland, OR (2019). Petitioner is a 25 year victim of human trafficking and has been protected by state and federal law enforcement for a long time. Petitioner has filed a tort claim against Marion County police. (Indianapolis, Indiana) Petitioner suffered a Level 6 Felony battery.

## REASONS FOR GRANTING THE PETITION

---

Petitioner did not receive her mail because it was stolen, Petitioner was unable to comply with court orders but should not lose her appeal due to the criminal actions of others.

Petitioner will try and arrange an alternative way to receive mail.

Petitioner did not receive the final order in time to request a re-hearing.
