When this case initially filed, June 12, 2015, I spent over \$15,000-\$20,000 in legal expenses with various lawyers. The District Court ( Newark NJ) wasted over 5 years, then the appeals court denied my appeal. 2 Days AFTER my civil matter was dismissed, the District Court employed entrapment, taking advantage of me burdening me w/ additional State charges, and 2 sham hearings, just to take away my firearms. Those appeals and losses including the 2 firearms, legal fees & State appellate fees ( which are going nowhere after a year & in excess of \$3500 and still counting. The U.S. Supreme Court will ultimately have to remedy State matters in addition to my erroneously dismissed civil matter. In short, remedies are expected, which include reinstatement. I declare under penalty of perjury that the foregoing is true and correct.
