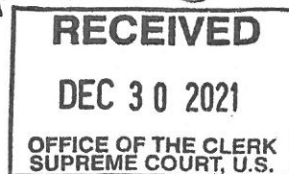
Here comes now, Vance K. Wilson, Jr., in pro-se capacity, moving this Honorable Court pursuant to Sup. Ct. R. 23 and 28 U.S.C. § 2101(F), to issue a stay order of district court proceedings until this court resolves its supervisory jurisdiction in the above titled and numbered case.

I

Mover has petitioned this Court for a writ of certiorari to review an interlocutory decision in the 22nd Judicial District Court, Parish of St. Tammany, State of Louisiana. The district court has informed mover that he is set for priority trial on February 14, 2021.

II

Mover has previously submitted applications for stay orders to this district court (see Exhibit A) and the Louisiana First Circuit Court of Appeal (see Exhibit B). Mover does not currently have any open cases



in the Supreme Court of Louisiana. All applications for stay orders have been denied.

III

A stay is appropriate because Mover has been prejudiced by the decision in January of 2021 to illegally revoke his bond, which he has petitioned this Court to review. By taking him to trial before this Court rules on this petition, Mover will not receive a fair trial due to the unresolved pretrial prejudicial issues detailed in his application for writ of certiorari.

Wherefore, mover respectfully petitions this Honorable Court for an order staying all trial proceedings in district Court until the resolution of the case under this docket number.

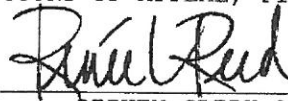

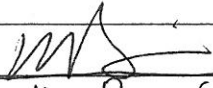

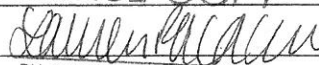
