After being fully informed by my counsel and by the Court of the charge against me, I am making a plea voluntarily with the understanding of the nature of the charge and the consequences, including the penalty of the plea, which can be from:

Count 1: Up to six (6) months in jail and/or

up to a \$1,000.00 fine,

in the appropriate penal institution. I understand that the Court upon acceptance of a plea of guilty may proceed with judgment and sentencing. I understand I have the right to a jury trial. I understand that at trial I have the right to confront and cross-examine the witnesses against me, and the right to have compulsory process for obtaining witnesses in my favor and to require the State to prove my guilt beyond a reasonable doubt at a trial at which I cannot be compelled to testify against myself. Upon conviction, I would have the further right of Appeal. However, I waive all those rights, including right to a trial by jury. I withdraw my former plea of "not guilty" and enter a plea of

"guilty" to the amended indictment charging me with the crime of
COUNT 1: THEFT (M1) (ORC 2913.02) (A) (3).

Furthermore, I am entering the plea of guilty after being fully informed by my counsel and by the Court of the elements of the charge. Those elements are:

Count 1: The Defendant did with purpose to deprive the owner, the State of Ohio, of property or services, shall knowingly obtain or exert control over either the property or services by deception, in Trumbull County, Ohio.

Furthermore, I have been informed by the Court and understand that I am (~~not~~) eligible for probation or (if applicable) that my plea of guilty may result in an additional sentence for a parole or probation violation and such sentence shall be consecutive. Furthermore, my counsel and I have fully discussed the facts and circumstances surrounding this case including the names of all witnesses. My attorney has investigated these facts and circumstances to the best of my knowledge and has discussed with me the making of or the necessity of pre-trial motions. I am, therefore, satisfied that I am now entering this plea with full understanding of my legal rights under the facts and circumstances as explained to me by my attorney and the Court. I have further advised my counsel and this Court that I am (~~not~~) a citizen of the United States of America.





JESSICA GORDON G

J Today's date is April 20, 2007 and I am in the office with Jessica Gordon and this is concerning Dwayne Stoutamire's case. Jessica, I talked to you before we turned on the taperecorder and asked you if I could taperecord this so I wouldn't have to write notes, correct?

G Yes.

J I want to ask you some questions about Dwayne and about his case. Let's start first of all about how long you've known him?

G [inaudible]

J October of 06?

G [inaudible]

J All right. Let's actually start with January 9, of 07 with the Antonio Peterman shooting. Now, when I ask you if you have any personal knowledge, I don't want to know about things that Dwayne or anybody else told you. Were you there? Did you have any involvement before or did you see anything?

G No.

J You know nothing about that?

G No.

J Let's jump ahead then to February I believe it's the 19th. The Peterman shooting was January 9th incident involving you and Dwayne where the police came was February 19th I believe? As I review the police reports and the audiotapes of the police transmissions it seems the police were sent out the Palmyra Road area. First of all, where you and Dwayne when the police came out? In other words, at somebody's house?

G We were in the car.

J Okay. In front of who's house?

G His friend's house.

J I am going to ask you to talk a little louder. Do you know the friend's

name or you do not?

G Red.

J Red?

G I don't know his real name.

J All right. Sorry about the interruption. We are back on the tape and you guys are at Red's house, could you tell me about, is that someplace you've been before or not?

G He goes there. I've been just to pick him up and stuff.

J Okay. Do you know Red's full name or you don't?

G No.

J No? All right. About what time of day or night is this, do you remember?

G In the middle of the night.

J In the middle of the night?

G [inaudible]

J And it appears that a neighbor called the police and said the two of you were fighting. Can you tell me from your recollection what happened with you and Dwayne out at the car?

G We was arguing we both were hitting on each other.

J I want you to hear me for a second because there is a difference when you are trying to paint a picture to a jury between fighting and arguing. Arguing implies to me that you're yelling and screaming at each other and maybe swearing at each other. Fighting implies that you may also be one or both of you may be swinging at the other one. Was there any physical contact?

G We was both fighting with each other. Arguing and fighting.

J Okay. So, are you hitting Dwayne?

G It was more arguing.

J Okay. Did Red or anybody from Red's house come outside when this was going on, that you saw?

G I don't know.

J Did you see any neighbors come out?

G No.

J As far as you can tell, it's just you and Dwayne?

G Um-huh.

J When the police come up, what's going on?

G We are in the car

J Still in the car, nobody's outside?

G Not when they first came up.

J Does anybody get out of the car?

G I got out of the car. And then he did, we both did.

J The prosecutor seems to be suggesting that the police are going to basically say when they pulled up, you got out of the car screaming 'he's got a gun, he's got a gun? Did you say that or did you not?

G Not that I recall.

J Did you see Dwayne with a gun that night?

G [inaudible]

J All right, let's back up, did you see Dwayne with a gun at anytime during this argument or fight?

G Him with it? No, there was one in the car.

J Yeah.

G [inaudible]

J You didn't see it, but there was one in the car?

G Yes.

J Where was the gun? Because it makes a difference in terms of whether it's accessible to him or not.

G [inaudible]

J Is it stuffed down between the seat, under the seat?

G [inaudible]

J Under the seat?

G I'm not sure.

J Okay. But it's not like he had it and he was pistol-whipping you?

G No.

J Or pointing it at you or anything like that?

G No, no.

J Do you ever tell the police that night that Dwayne had struck you?

G I mean, they could tell.

J They could tell, okay. Did you ever tell the police that Dwayne had held you against your will?

G No.

J Because you understand, he's really charged with abduction?

G No, I told them that I got dropped off with him.

J Okay. When, what do you mean you got dropped off - ?

G My friend Jen dropped me off at his mom's house earlier in the evening when we were out together, riding around talking and everything. And then we stopped there.

J Okay. Stop, there being at Red's.

G Yeah.

J Okay. So Jen drops you and Dwayne off at Karen's house.

G No, she dropped me off with Dwayne at Karen's house. He was already at his mom's.

J Oh, okay.

G Me and my friend, Jen were - .

J Okay. So Jen takes you over to Karen's house where Dwayne is? Then you and Dwayne go out riding around later by yourselves? Then you go over to Red's house and it's in the driveway at Red's house that you get in this fight?

G Yes.

J All right, got you. Now, do the police then take you away that night? Do they take you into custody, separate from Dwayne?

G Not at that time.

J What happens? How do you - - ?

G They, I went to the police station, they said that they had to get the police report down there.

J How did you go to the police station? Did you drive?

G No, they took me.

J They took you, All right. When you were in the police car going to the police station, did you tell them that Dwayne had bragged to you about shooting Antonio Peterson?

G Not that I remember. I was drunk.

J You were drunk? That's fine. That's what we need to know.

G Yeah, I was pretty out of it that night, you know. Honestly, I don't even remember much of it.

J You don't remember too much?

G Yeah.

J Okay, well, that's fine. Let's talk about that because see what we have to do is, we have to track, whether it's a flattering one or not, we have to try to paint a realistic picture for a jury who doesn't know anything about this case, who is going to be asked to decide whether Dwayne's guilty or not. We have to paint a realistic picture, so if the answer is that I'm so drunk that I don't remember much, and then okay, that's the answer. Let's talk about what you would have consumed that night that you could remember. And here's why, not because I'm trying to throw down on you or anything, because when you tell a jury that you're under the influence and you don't remember a lot, if you say well, I had a glass of wine with dinner and I was just a little bit tipsy, that's one thing, but if you say, listen, I had a bottle of Mad Dog 20/20, I drank the whole damn thing myself and I dissolved a couple of Valium capsules in it. There's a big difference there, okay? So, it isn't that I'm trying to embarrass you or throw down you, but we have to be able to realistically tell them what the condition was. So - - .

G I drank a bottle of gin.

J When you say a bottle, how big a bottle?

G A fifth.

J A fifth?

G Yeah.

J By yourself?

G No, me and Jennie.

J Had you had that before you went over to Karen's house?

G Yes.

J Okay.

G I still was drinking when we were—

J When you were at Karen's house?

G No, I wasn't, when I got dropped off at her house, I didn't even go in. Like he just came out.

J I see.

G I got into Jen's car and then his mom's car and we left. Jumped from one car to the next.

J All right. You said something about still drinking?

G Yeah, I was.

J Were you still drinking in Jen's car on the way over there, is that what you're saying?

G We were drinking, yeah. And with Dwayne.

J Okay, so you and Dwayne are also drinking?

G I was drinking.

J All right. What were you drinking when you were riding around with Dwayne?

G Gin.

J Gin, All right.

G Gin and juice.

J Gin and juice?

G Well, gin and [inaudible]

J Is this something you'd mix up yourself or do you buy it that way, mixed it up?

G yeah.

J Okay. So, excluding the punch for a second to try to get some idea of how

much alcohol you had, how much alcohol would you say you had? Did you have a bottle of gin? A half a bottle?

G [inaudible]

J Yeah.

G Probably, I don't know, me and her, we drank it, the whole bottle and probably half a bottle or [inaudible]

J So you probably had about half a bottle of gin?

G We split it, yeah.

J Did you have anything else? Any marijuana? Any crack cocaine? Any cocaine? Any pills?

G No, ah I had —I don't know— no, no.

J No? Did Dwayne have anything that night that you saw?

G Not that I know of.

J Okay. So you said that you were drinking in the car, it was just you, it wasn't Dwayne?

G No, he might have had a sip, I don't know. I don't . . .

J That you remember, okay.

G I don't remember.

J Would you be too trashed to remember he was trashed when he came out, when you got to Karen's house, he came out and you two got in the car, could you tell if he had already been drinking?

G No, he was cool.

J He was okay?

G Yes.

J How long would you say the two of you were riding around before you went over to Red's house?

G I have no idea. Ah, probably a couple hours.

J Couple of hours?

G Or an hour, I don't remember.

J All right. Were you, let me ask you, were you pissed at Dwayne when the

cops showed up?

G Yeah, I was mad at him.

J You were mad at him, okay. Really what I'm trying to find out is, these cops as I understand it are going to say that when they were taking you to the station to fill out this report, you're going, listen, he was involved in the Antonio Peterman's shooting, he told me that. I guess I need to know a couple of things for my own purpose is, first of all, did Dwayne ever tell you that?

G No, I heard it.

J You heard it, okay. So Dwayne never told you he was involved in the Antonio Peterman shooting. So if you, and you don't remember one way or the other whether you told the cops that or not that night?

G I have, no, no.

J But if you did - -

G It's probably because I was mad.

J Because you were mad and it had to be something that somebody else told you, not that Dwayne told you?

G Uh-hum.

J Okay. Anything else that you remember that you said to the police?

G No.

J No, okay.

G But I told them when they were doing the report, and they were like, here's all the charges against me and they were saying the abduction stuff and everything. I told them even then, like where do you get that from, because I got dropped off with him. Do you know what I mean?

J Uh-hum.

G And they just still—

J Abduction can be any time that somebody holds you against your will or makes you go from one place. For example, you're here in my office now, it's a Friday afternoon at 3:35, you came here voluntarily with Karen. Nobody put a gun to your head. You and I talked a few weeks ago at the pretrial and said we'd get together. But my point is this: even though you came here voluntarily, if I came over there and grabbed you and forced you and said, I want you to go into the conference room down the hall and you go, no, I don't want to. Or I want you to go into this bathroom right here, and you say, no, I don't want to. See, my point is that, just because Jen dropped you

off at Dwayne's, doesn't mean that he can't --.

G I didn't want to leave [inaudible]

J You didn't want to leave where?

G Like I was in the car with him. Like we were fighting and he says he wanted me to go and I didn't want to. You know what I mean? Like it wasn't very [inaudible]

J He wanted you to go home?

G Yeah.

J Okay, and you didn't want to leave him?

G Yeah.

J That's what the argument was about?

G Um-hum.

J Okay. So it's hard to say he was holding you against your will when he was the one basically saying, get the hell out of here?

G Yeah.

J Where did you live in connection with Red? In other words.

G Probably I live on the eastside and we were on the westside.

J Okay. So when you're fighting about this, he basically, what, wants to drive you home? Or is he telling you to get the hell out of the car?

G He said he wouldn't take me home [inaudible] just get out -- he just wanted me to get out of the car.

J Okay. Was he kind of pissed off at you being so drunk?

G No, I wasn't like, I mean, no we wasn't fighting about that. We were fighting, we had been fighting.

J I see, All right. And he's basically saying, you know, I don't want to have anything to do with you tonight, I just want to take you home. And you're fighting and said, I don't want to go home, I want to stay with you? That kind of thing?

G Um-hum.

J And do you tell that to the police?

G Yeah, I told them that we were arguing.

J Okay. Did you ever tell that to any prosecutor?

G I told that to him and the grand jury. Like I, when we had the grand jury, thing, I don't know where you guys get this kidnaping and stuff because I got dropped off with him, I wanted to stay with him. And they just—

J They just did what they did.

G Yeah.

J Okay. But in terms of what you told them, you told them that you got dropped off by Jen and you didn't want to leave Dwayne and all that kind of stuff?

G Um-hum.

J You had mentioned to me when we talked in the courthouse, Jessie you mentioned to me when we talked in the courthouse that you were going to get down to the Warren P.D. and get your statement because

G I didn't ever go get it.

J You didn't, okay, All right. The only statement you made is the one that you made the night, the morning, the early morning that the police took you in there and said you got to write a report about what happened.
