

- 7) I was on the edge of death because I got infected with covid-19. and I had no help on the GEO- at la villa TX. this is on there Medical Record where i explain for help and I had none I felt Really bad.
- 8) a minor cause is 1 point only and she gave me 4. Points for a minor cause, and for my felony from 2005. and it shouldn't count because it was a long time ago. it's been more than 15 years.

#### STATEMENT OF THE CASE

The district court erred in sentencing Mr. Ramirez Rodríguez. 1) The sentencing Judge exceeded the sentencing Guidelines. Mr. Ramirez Rodríguez was sentenced to 95 months instead of 71-77 months.

2) The sentencing Judge did not give Mr. Ramirez Rodríguez the 3 point reduction, 2 for pleading guilty and 1 point for the actual sentence. The sentencing Judge never reduced the points.

3) Mr. Ramirez Rodríguez Felonies From June 18<sup>th</sup> 2005 are more than 15 years. and they should not have been calculated to Criminal history. He was also given 4 points for misdemeanor in which he should have received 1 point instead.


#### REASONS FOR GRANTING THE PETITION

mr. Ramirez Rodríguez was sentenced to 95 months in federal prison in which he should have received 71-77 months, almost 2 years. additional time. The district court erred by not giving mr. Ramirez Rodríguez the 3 point reduction. mr. Ramirez Rodríguez is in Federal Custody for Re-entry only. He just wanted to live a better life in a country that offers better opportunity, that's all. He has children who are American citizens, one son and one daughter, who he love and care for. Mr. Ramirez Rodríguez ask this honorable Court to have mercy and compassion allowing him an opportunity to reunite with his family within the 71-77 months instead of 95 months to prevent a miscarriage of justice.

## **CONCLUSION**

The petition for a writ of certiorari should be granted.
