Dear Mr. Gaines

The United States Postal Service has denied you for non-sensitive clearance. If you wish to file an appeal with the U.S. Postal Service regarding this denial, you have 30 days from the date of the denial letter (June 29, 2021) to file an appeal. Please follow the instructions in the attached letter. You are encouraged to gather the necessary documentation for your appeal and forward it to the U.S. Postal Service as soon as possible.

You will be placed on suspension without pay pending the outcome of your appeal. If your denial is overturned, you will be reinstated. If your denial is upheld, your employment will be terminated. If you do not file an appeal, your employment with FedEx Express will be terminated. Suspensions and terminations that occur as a result of a denial of a non-sensitive clearance are not eligible issues for the Guaranteed Fair Treatment Procedure (GFTP) process.
