MOTION TO APPEAR IN FORMA PAUPERIS

COMES NOW, the Petitioner, OLRY MAURIVAL, by and through his undersigned counsel, and requests this Court permit him to proceed in Forma Pauperis, pursuant to S.Ct. R. 39, and in support thereof states and alleges as follows:

1. The accompanying Petition for Writ of Certiorari is part of the continuation of a direct appeal arising from the Southern District of Florida, and the affirming decision from the 11th Circuit Court of Appeal.¹
2. Petitioner has been incarcerated since a jury found him guilty of all counts in the Indictment on September 16, 2019. He has attached an executed Financial Affidavit showing that he has no assets, whether real property, personal property or financial liquidity of any sort. He is incarcerated at FDC Miami, and due to the COVID-19 pandemic, was unable to secure a counsel or other Notary Public to Acknowledge his signature. He has attached, in addition to his signed Financial Affidavit, (a copy of which is attached as Exhibit "A"), copies of efforts made to secure this notarization through the inmate email system to prison authorities known as Trulincs on August 5, 2021 and, again, on August 10, 2021. His efforts were ignored.²
3. Counsel is on even date hereof submitting his Petition for Certiorari.

WHEREFORE, the Petitioner asks this Honorable Court to enter an order finding Petitioner indigent, and, pursuant to S.Ct. R. 39, find favorably as to application to proceed in Forma Pauperis.
