PETITION FOR REHEARING FOR JUSTICE GORSUCH

Comes Now, Christopher D. Cobb, proceeding Pro Se, to request Justice Gorsuch to support his Request for Rehearing. Support for which follows:

1. The decisions of the lower courts, as well as this Court's denial of certiorari, runs afoul of Smith v United States, 96 S.Ct. 2, 46 L.Ed 2d 9, 423 U.S. 1303, 1307-08 (1975): "[A]ll constitutional guarantees extend both to rich and poor alike, to those with notorious reputations, as well as to those who are models of upright Citizenship. No regime under the rule of law could comport with constitutional standard that drew such distinctions"

The constitution specifically guarantees that all officers of the State shall swear an Oath of Office. Despite evidence that Gallagher did not do so, the Eleventh Circuit declared that she had, with nothing before it to support such a conclusion. The district court determined that she had not, but that this lack was "harmless". This places Gallagher into a position of supremacy over Cobb. Gallagher has been afforded protections which are not enumerated in any document of our Republic, save these two lower decisions, whereas Cobb, having presented the illegallity of the proceedings, has been afforded none of the guaranteed protections of the Constitution, Statute, Federal Rules, or prior precedent of this Court; all presentations of which he has made to be in his favor. He has been procedurally barred based upon a case that was essentially overturned two years later, yet not declared to be overturned; which created a loophole for unlawful prosecutions that has in turns been upheld and denied. None of this comports with our Founding Father's intentions of Rule of Law or for guaranteeing that Justice will prevail, and prevail blindly without regard for class or social status.

Accordingly, Cobb asks for your intervention as an Originalist, to fix this loophole of injustice.


