MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

The Petitioner asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*. Petitioner has been incarcerated since April 16, 2019. Counsel has been court-appointed to represent Petitioner since August 28, 2019; before then Petitioner had court-appointed counsel through the Federal Public Defender's office. Petitioner has previously been found indigent by the Southern District of Iowa and the Eighth Circuit Court of Appeals. Leave to proceed *in forma pauperis* has not previously been sought. Petitioner's 2019 Financial Affidavit and prior Orders finding him indigent are attached in support of this motion. Petitioner will supplement a more recent Financial Affidavit if necessary.




