## QUESTIONS PRESENTED

1. Does the Mentor Ohio Municipal and Lake County Ohio Court of Common Pleas have any lawful and legitimate jurisdiction to reach out and try Dual-Seedline Christian Identity / White Supremacist Pastor Lindstedt and his Church of Jesus Christ Christian / Aryan Nations living 900 miles away for what was said about limited purpose public figure and proven state and federal agent provocateur Bryan Reo well outside the Ohio Statutes of Limitation for alleged “defamation” or “false light” much less assess “punitive damages” given that no actual damages were ever computed by Bryan Reo?
2. Do state or federal courts have the authority to reward their officers with a monopoly license against Defendant non-lawyers to not allow them to represent in their regime courts their Churches and family members who are under attack by these licensed “officers of the courts” attorneys using civil lawfare?
3. Can these courts both trial and appellate rule that white supremacist and Aryan Nations pastors be limited in their briefs and defenses to not presenting their defenses that *of course* they are religiously racist and refuse to recognize the legitimacy and jurisdiction of these courts or to be tried by non-whites and “liberals” on the jury or the judiciary or to pretend that they received a “fair trial”?
4. Is this court prepared to take any responsibility that aggrieved white supremacists and their racially religious churches intend to use biological and

nuclear weapons against their subject populations both non-white and white in retaliation for running corrupt judicial process in their courts of no legitimate or inherently lawful jurisdiction? Or to accept that this total civil warfare using weapons of mass destruction by rebels won't be limited to just Northeastern Ohio but to other states and areas for their enforcing these lawless judgments?

This Petition for a Writ of Certiorari is really nothing more than an excuse for fighting and winning this Second Civil War by destroying the legal and moral foundations along with 300 million ZOGlings of the current Mighty Evil Empire satanically working to destroy YHWH's Servant Nation of Aryan Christian Israel.

Other parties **served but not brought to trial**. See Appendix “B” Judgment of Lake County trial court:

Clifton Emahiser, another jew pretending to be Christian Identity, probably killed by William Finck in 2018 and not brought to trial.

William Finck, Panama City Florida. A Jersey City jew who murdered a Puerto Rican sneak thief and snitched out a fellow jailer who committed the crime, took a plea bargain from the federal government and was installed as a federal agent provocateur pretending to be Christian Identity pastor and represented by Bryan Reo (before he became a lawyer), who never showed up to trial.

William Shawn DeClue of Florissant Missouri working with Bryan Reo likewise counter-claimed who never showed up to trial.

Roxie Fausnaught, Granby, Missouri, Pastor Lindstedt’s bed-bound illiterate 63-year-old woman who was unable to appear because of broken hip who Bryan Reo sued but didn’t bother to present evidence against. Declared innocent or ignored by the jury and trial court judge. Died 3 Aug. 2020.

### RELATED CASES:

There are 20+ cases by Bryan Reo against Pastor Lindstedt, his Aryan Nations Church and sister in Ohio state and federal courts, Missouri state and federal courts, and Stanley County South Dakota. Below are some of them since 2014:

*Reo v. Lindstedt* 1:14-cv-00816-JG Northern District of Ohio for \$10.75 million transferred to Western District of Missouri . *Reo v. Lindstedt* 3:14-cv-05093 transferred to WDMo dismissed 10 Sept. 2015. Pastor Lindstedt filed an appeal in the 8<sup>th</sup> Circuit Court of Appeals regarding Bryan Reo abuse of the Digital Millennium Copyright Act but that litigation went nowhere.

*Bryan Reo v. Martin Lindstedt* , # 15 –CV-001590 in the Lake County Ohio Court of Common Pleas filed by Bryan Reo on 18 Sept. 2015 which is the case on appeal

*Bryan Reo v. The Church of Jesus Christ Christian and Martin Lindstedt and Roxie Fausnaught* #16-CVE-245 before the Mentor Ohio Municipal Court on March 22, 2016 which municipal court disclaimed jurisdiction and sent up to the Lake County Court.

*Bryan Reo v. The Church of Jesus Christ Christian and Martin Lindstedt and Roxie Fausnaught* #16-CV-000825 in the Lake County Ohio Court which was joined with the *Reo v. Martin Lindstedt* # 15-CV-001590 case and eventually went to trial on 24-26 June 2019 and is the basis for this Petition for Writ of Certiorari.

There have been around 20 other cases by Bryan Reo and his family against Pastor Lindstedt, his Aryan Nations Church, Roxie Fausnaught, and his sister Susan Bessman since in order to get at Pastor Lindstedt's South Dakota inheritance and Missouri real and personal property.

## **CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED**

Neither Pastor Lindstedt nor his Aryan Nations Church wish to pretend that the Constitution of the United States or the Bill of Rights are anything other than dead-letters designed to enslave and entrap the sundry slave populations subject to federal and state claims of rulership, authority and jurisdiction. The “laws” of Ohio are as the “laws” of Sodom and Gomorrah and the other Three Cities of the Plain which were used to claim under color of their law a false dominion enabling them to kidnap, rob and murder strangers under color of their law for which they were punished by fire and brimstone and the destruction of them all by YHWH and YHWH’s Servants. Thus the operative True Law of YHWH has been published in Genesis Chapter 18 and 19 and further expounded by the Book of Jasher Chapters 18 and 19 which can be viewed here:

Also Pastor Lindstedt invokes the Declaration of Independence which is both the Birth Certificate and the Death Warrant for this Satanic Mighty Evil Empire and her sundry united states whore daughters in that whenever anyone and his People find this form of government oppressive or tyrannical we have the duty and the right to alter, abolish and amend it and replace it with something else such as a series of independent whites-only theocratic local military dictatorships such as

the Ten Thousand Warlords over 10-30 million chastised ex-whigger ZOGling herd animals.

Thus ever since 13 June 2016 when Pastor Lindstedt learned that a 7 June 2016 ORDER from Lake County Ohio Judge Collins added Pastor Lindstedt's Aryan Nations Church and Lindstedt's elderly illiterate bed-bound woman Roxie Fausnaught to Bryan Reo litigation Pastor Lindstedt has determined to treat Northeast Ohio acting like Sodom and Gomorrah just like Sodom and Gomorrah and to "quartrillize" Northeastern Ohio and then to chernobylize the North Perry Nuclear Power Plant and turn Lake Erie into a Dead Sea as an end point of this Second Civil War for the Independence and survival of YHWH's Servant Nation od Aryan Christian Israel as part of the Great Tribulation / Collapse of Empire.

## **STATEMENT OF THE CASE**

1. The Mentor Ohio Municipal and Lake County Ohio Court of Common Pleas lacked any lawful and legitimate jurisdiction to reach out and try Dual-Seedline Christian Identity / White Supremacist Pastor Lindstedt and his Church of Jesus Christ Christian / Aryan Nations living 900 miles away for what was said about limited purpose public figure and proven state and federal agent provocateur Bryan Reo well outside the Ohio Statutes of Limitation for alleged "defamation" or "false Light" any more than the judiciary of Sodom & Gomorrah & the Other

Three Cities of the Plains did during the time of Abraham or against Abraham's People in kidnapping travelers on the caravan route between the Red Sea port of Aquiba and Babylon to kidnap, rob and murder them under color of legal process circa 2000 BC. As mentioned above since the Ohio state and federal courts act like Sodom and Gomorrah their population shall be treated accordingly harshly.

2. The conceit of the state and federal courts is that Pastor Lindstedt because he isn't a licensed attorney could not defend His Aryan Nations Church or his elderly bed-bound illiterate domestic partner Roxie Fausnaught and has to obey the corrupt judge-made Rules of their regime courts without any jurisdiction. Thus this civil lawfare involving not only this case but 20+ other cases in the Lake County and Ohio federal courts and in Missouri and South Dakota in order to take Pastor Lindstedt's property means that the sundry federal and state courts are allowing a non-white agent provocateur to use these courts to destroy under color of law white supremacist and racial religious dissenter Pastor Lindstedt and his Aryan Nations Church. The end result of this policy of civil lawfare shall be civil warfare justifying the extermination of the current state and federal regimes, their officials and employees and their families, especially in Northeastern Ohio but South Dakota and Missouri as well.

3. The 11<sup>th</sup> District Ohio Court of Appeals several times made Pastor Lindstedt redraft his Appellate Briefs because of his open Biblical racism and a refusal to

pay much, if any, attention to their “briefing rules.” Pastor Lindstedt also refuses to accept that he was tried by a corrupt trial court judge absent any lawful jurisdiction and a hostile jury in which one of the jurors was a literal African female from Africa and the seven other liberal whites didn’t care that Bryan Reo was a non-white non-heterosexual fake-white supremacist involved with other agents provocateur lawyers involved in Charlottesville in August 2017 (and possibly the January 6<sup>th</sup> 2021 “Insurrection”). Thus this case involves a non-white federal agent provocateur going against an openly white supremacist Aryan Nations pastor and his Aryan Nations Church who has for the past 30 years advocated using biological and nuclear weaponry in order to destroy all the jews and non-whites and a lot of degenerate whites in order to abolish the current federal form of government and replacing it local theocratic/military dictatorships ruling over 10-30 million whites only, i.e. the Ten Thousand Warlords Project.

4. Since 13 June 2016 in response to this Lake County judge allowing Bryan Reo to sue his Aryan Nations Church and domestic partner and refusal to allow Pastor Lindstedt to defend them after Bryan Reo who was fired from his job at the North Perry Nuclear Power Plant because of Pastor Lindstedt’s Aryan Nations web pages documenting Bryan Reo/SwordBrethren past Movement history has summoned an ecclesiastical court to judge that according to YHWH’s Law what was done to Sodom and Gomorrah should also be done to Northeastern Ohio by White

Supremacists and Aryan Nations chernobylng the North Perry Nuclear Power Plant and thus creating a radioactive gulag reservation for non-whites and jews and regime criminals and their families to ensure that there never is another federal regime and turning Lake Erie into another Dead Sea. Likewise since March 2020 Pastor Lindstedt has advocated destroying the Missouri River impoundments as a punishment for the state of South Dakota going after his sister who received back his South Dakota inheritance Bryan Reo is after as a suitable punishment for these states enforcing corrupt Ohio court decisions against Pastor Lindstedt and his Aryan Nations Church.
