1 ask him where you are.

2 Q. What did he tell you?

3 A. He said, "Oh, we're at a casino." Oh, I believe first  
4 thing -- I don't really recall. I believe he said, "We're in  
5 San Diego. We are in San Diego."

6 I said, "What are you doing in San Diego?"

7 "Oh, we're in a casino. Me and my wife are at a casino."

8 Q. So explain to the jury, you know, what are you -- what  
9 have you been doing at your home in the month prior? I mean,  
10 have you been working?

11 A. I mean, no, I haven't been working. The motorcycle --  
12 becoming a police officer -- becoming a motor officer was like  
13 a big dream for me to become, and I went through everything.  
14 It took me about a year and a half to buy my own motorcycle,  
15 practice to become a motor officer. So the motor officer was a  
16 dream for me. It was a big accomplishment.

17 So when I crashed my motorcycle and the doctors were  
18 saying that they don't even know if I can ever ride, that was  
19 traumatic for me, you know? So I was going through a lot of  
20 stuff, peer counseling from LAPD and, you know, chiro,  
21 acupuncture, and all the nine yards.

22 The other thing is I've never in my life sat home for  
23 seven months without doing anything. So I was just -- I was  
24 just pretty much confined to my residence. So I was a little  
25 overwhelmed, you know? I just -- I wanted to do something, but

1. I don't know what to do.

2. Q. So what is it that -- that Victor said to you --

3. Mr. Ramirez said to you on the phone that sparked your  
4. interest?

5. A. So when he mentioned -- when he mentioned, "I'm at the  
6. casino with my wife" -- and at that time, my wife -- my wife --  
7. my wife had just got back, like, ten days ago. I was a single  
8. father for, like, two years. So my wife had just got back from  
9. Mexico, and it was -- it was a good feeling.

10. And the whole thing -- and then she was driving me around  
11. to the doctor because I couldn't really drive. She was driving  
12. me around to my doctor's appointment when this thing -- when --  
13. before this incident happened.

14. So when he called me and he says, "Hey, I'm in San Diego  
15. with my wife," I'm thinking maybe I need to get -- maybe I need  
16. to step out and have a drink. And the good thing is I have  
17. someone that can drive me because -- and then I asked my wife.

18. Q. So let me ask you this.

19. A. Yeah.

20. Q. So you were under the impression they were at a casino in  
21. San Diego somewhere?

22. A. Sure. Yes, sir.

23. Q. Okay. I'm sorry. Did he say "casino"?

24. A. He said "casino," yes, sir.

25. Q. Okay. And so you felt that he was in San Diego somewhere?

1 A. Yes, I believe -- when he said "casino," I believe he  
2 mentioned -- I don't recall him saying, "El Centro," but I  
3 thought I heard "El Cajon," and I know where El Cajon is.

4 Q. Okay.

5 A. So I believe he said, "El Cajon."

6 Q. In your -- in your mind, how far is El Cajon from Fontana?

7 A. El Cajon from Fontana -- we're talking about hour and a  
8 half.

9 Q. And so you decided that, you know, maybe you should -- you  
10 can get out?

11 MR. COUGHLIN: Objection. Leading.

12 BY MR. CARLOS:

13 Q. Did you --

14 THE COURT: Sustained.

15 BY MR. CARLOS:

16 Q. Okay. What did you do after the call?

17 A. So once I got the call, again, like I said, I didn't want  
18 to drive -- you know, if it was up to me, I'm not going to  
19 drive to El Cajon due to, you know, my limited ability of  
20 moving around.

21 So the first thing I did is I asked my wife, "Hey, do you  
22 want to go to the casino?"

23 My wife: "No. Since when have you started gambling?"

24 So right now, I'm trying to think, "How can I convince  
25 this lady to get me out of here so I can go and have a drink?"

1 Q. Did you convince her?

2 A. I did. I mean, she gave me all kind of excuses, but I  
3 was, like, "Oh, you know, I'm sick. I just want to get out of  
4 here. Let's just go out."

5 And then she end up -- yeah, she end up driving me out.

6 We end up heading down there.

7 Q. So do you recall when you got that call?

8 A. Like I said, I could only refer the call to my kids coming  
9 home from school after -- it could be anywhere between  
10 5:00 p.m. and 6:00 p.m.

11 Q. Okay. I'm going to show you what's been marked previously  
12 as Government's Exhibit 53. You've heard testimony on this.  
13 I'm going to just show the evidence tag. Then we'll go to  
14 Page 2 of this.

15 So that we're clear -- so this is -- this is from your  
16 phone; correct?

17 A. Yes. Yes, sir.

18 Q. So at the top, there's -- there's an outgoing call for --  
19 from WhatsApp Messenger, Mambasse Patara, but that's on  
20 March 29th; correct?

21 A. Yes, sir.

22 Q. All right. And then it goes down to April 23rd, and  
23 there's an incoming call from Victor Construction. Is that the  
24 call that you're talking about?

25 A. I believe so if that's the only one -- if that is the only

1 Q. Okay. Do you know the names of any casinos in San Diego?

2 A. I knew the name of at least two.

3 Q. Okay. Is that where you believed you were going to meet

4 them at?

5 A. No, sir.

6 Q. Okay. Did he name the casino you were going to meet at?

7 A. No, sir.

8 Q. That's why an address was sent?

9 A. Yes, sir.

10 Q. Did you assume that that was going to be -- where did you

11 assume that was going to be?

12 A. I thought -- I thought that was either the casino or an

13 address next to the casino.

14 Q. Let me ask you this: When you drove down the 15 from

15 Fontana, did you pass any U.S. Border Patrol checkpoints?

16 A. Yes, sir.

17 Q. Where did you pass one at?

18 A. There was one on -- in Temecula.

19 Q. Is that northbound on the 15?

20 A. It's -- it's actually -- it was actually exactly

21 southbound of 15 from -- about five miles from Fallbrook, west

22 of Fallbrook.

23 Q. Okay. So you saw immigration checkpoints. Is that --

24 A. Yes, sir.

25 Q. Okay. In order to get back to -- to Fontana, you would

1 strange that you didn't stop at the place where they wanted you  
2 to stop. Do you recall that?

3 A. Yes, sir.

4 Q. Describe for the jury the process that you did in order to  
5 ultimately come to a stop at that checkpoint.

6 A. Okay. At checkpoint -- assume there's a U.S. entry  
7 checkpoint. And so as a law enforcement officer, I've worked a  
8 lot of checkpoints, the U.S. checkpoint, you know, and the  
9 driver's checkpoint. There's a lot of stuff that happens at  
10 checkpoint. People drive through it. Officers get injured.  
11 People get drunk and do crazy stuff.

12 When I was coming to the checkpoint, the 15 minutes that I  
13 drove, I was the only car on the freeway. So when I was  
14 approaching the checkpoint, everything was open. I see two  
15 stop signs, one further, one in the back. I don't know exactly  
16 where to stop. The only thing I can do at this time is slow  
17 down.

18 Q. Why did you slow down?

19 A. Because -- so we can -- we can be on the same level, so I  
20 can communicate with this guy.

21 Q. Who's "we"? You said, "We can be on the same level."  
22 Who?

23 A. There's law enforcement. That's the checkpoint. I saw a  
24 bunch of guys talking. We don't have eye contact at a stop  
25 sign.

1 Q. Why is eye contact important to you?

2 A. Eye contact is important because it's a way of

3 communication, so we can be on the same level, so we know -- we

4 all know what we're doing. When -- like I said, when I do a

5 checkpoint -- when I work checkpoint, there's an officer,

6 always the slowest cars that are coming, slow down, stop. And

7 another officer take it from there, talk to the officer, which

8 is the contact officer. And once you're done, another officer

9 tells you, "Bye."

10 So that's the communication, so people don't get hurt..

11 Q. So what did you do in this case?

12 A. What I did in this case -- the only thing I can do at this

13 point is slow -- I slow down. When I slowed down, I saw a K9.

14 I saw a dog, a police officer with a K9, a K9, you know,

15 getting ready to go on the street. The only thing I can do is

16 slow down before I hit the K9. If you hit a K9, a K9 is also a

17 police officer.

18 Okay. So I stopped for the K9, which I think is a sign of

19 respect. I slowed down, and I stopped. I stopped on purpose

20 because I wanted to visually make eye contact with someone, and

21 I want someone to bring them in other than me just driving

22 through it. It is a sign of respect.

23 Q. So is that what you did? You stopped?

24 A. Yes, sir.

25 Q. And did you then proceed to the place to stop?

1 A. When I stopped, I actually made eye contact with an  
2 officer. They brought me in and asked me where to stop.

3 Q. Okay. I'd like to show Government's Exhibit No. 5, which  
4 is the video.

5 So is this the dog that you're talking about? The barking  
6 dog?

7 A. Yes, sir.

8 Q. How close was he to your wheel at that point?

9 Please stop it. Thank you.

10 Do you recall?

11 A. Not really. I'd say maybe 25 -- maybe anywhere between 20  
12 to 50 (Inaudible).

13 THE REPORTER: I'm sorry. "20 to..."

14 THE WITNESS: I was going to say metric system but  
15 probably about three feet.

16 BY MR. CARLOS:

17 Q. Three feet.

18 Okay. So you approached. We saw what you -- it looked  
19 like you slowed. The dog was barking. That's where you  
20 stopped initially; correct?

21 A. Yes, sir.

22 Q. And you said that there were two stop signs. Is the stop  
23 sign -- one stop sign by the cone that's to the side of your  
24 car? Correct?

25 A. Yes, sir.

1 Q. And the other stop sign is in front of the vehicle?

2 A. Yes, sir.

3 Q. And you ultimately come to the stop -- stop at the sign

4 that's in front of your vehicle?

5 A. Yes, sir.

6 Q. All right. And the officers are there; right?

7 A. Yes, sir.

8 Q. Did they express any dismay about the fact that you didn't

9 stop?

10 A. No, sir.

11 Q. Did they -- did they scream and yell about why you didn't

12 stop where they told you to stop?

13 A. No, sir.

14 Q. Did any of them pull their weapon out, expose it at you?

15 A. No, sir.

16 Q. Did any -- did any of them make anything -- any -- any

17 movements which you would -- you would attribute to them being

18 in fear for their safety?

19 A. No, sir.

20 Q. So what happened at the stop?

21 A. So I come to a stop. I come to a stop, and then the first

22 thing I did is lower my windows, my driver's side window.

23 First thing I do -- officers -- I treat them like I like to be

24 treated when I'm working on duty. Either I say, "Good morning"

25 or "Good evening, sir."

1           He said, "Good morning." His next question is "Where are  
2           you coming from?"

3           My answer is "From the casino."

4           Q.    What did they ask you next?

5           A.    His next question is "Are you a U.S. citizen?"

6           Q.    What did you respond?

7           A.    I said, "Yes, I'm a U.S. citizen."

8           Q.    What did they ask you next?

9           A.    Well, when he asked me, "Are you a U.S. citizen?" and I  
10          say, "Yes, I'm a U.S. citizen," the next thing I did -- I reach  
11          out in my pocket, pull out my wallet, and my wallet was right  
12          next to my gun. Yes.

13          Q.    And for the record, you're indicating -- you're using your  
14          right hand. You're moving it back towards your hip --

15          A.    Yes.

16          Q.    -- right?

17          And then you reach into -- you said that you brushed your  
18          weapon against your waistband?

19          A.    Yes, sir.

20          Q.    Was it in a holster or just stuck in your -- your  
21          waistband?

22          A.    It was in a holster.

23          Q.    Okay. On your -- on your belt?

24          A.    On my belt, yes, sir.

25          Q.    Okay. So you felt the weapon there as you were reaching

1 for your -- for your ID's?

2 A. Yes, sir.

3 Q. Okay. So what did you do then?

4 A. The next thing that I did -- when I opened my wallet, I  
5 pulled out my California driver's license --

6 Q. Okay.

7 A. -- out of my wallet.

8 Q. And then what happened?

9 A. The officer was by the window. As I was showing him my  
10 California ID card, my California ID card and my police -- my  
11 police ID card is directly behind -- underneath my California  
12 ID card.

13 As I was pulling everything out visibly -- so as I pulled  
14 out the California ID card, my police ID card came, and my next  
15 answer was "I'm also off-duty police officer." Everything was  
16 visible through the window.

17 MR. CARLOS: Can you switch back over to the ELMO?

18 Thank you.

19 BY MR. CARLOS:

20 Q. All right. I'm going to show you what's been previously  
21 marked as Government's Exhibit 8. Do you recognize this --  
22 this photo?

23 A. Yes, sir.

24 Q. What are these photos of?

25 A. This photo is a card that I carry in my wallet. These

1 are --

2 Q. Let's start over here in the right corner.

3 The thing that says, "VA." What is that?

4 A. The top one says, "VA." That's my discharge -- that's my  
5 Marine Corps discharge card. Okay? And I always carry that  
6 card for me because I was discharged as an E5 in the Marine  
7 Corps. That's a pride for me. Everywhere I go, I carry it  
8 because I believe it's something that I earn. I already have a  
9 pride on it.

10 Q. What's the VA thing at the -- below it?

11 A. The VA thing below it -- when I went to Iraq, I was a  
12 combat veteran. I got hurt. So I'm a -- I'm a combat veteran,  
13 and I got a disability.

14 Q. So is that --

15 A. So this card means a lot to me. I carry it, too.

16 Q. Is that a photo of you in your police officer's uniform?

17 A. Yes, sir.

18 Q. That was with you on this day also; correct?

19 A. Yes, sir.

20 Q. You have two -- looks like bank cards?

21 A. The U.S. Bank card. On top of it, that is a motorcycle  
22 officer. I have the privilege -- the City gave me a free gas  
23 card that I use for my motorcycle. That's also a pride. I  
24 take really pride in it because not everybody gets it. So I'll  
25 carry it with me, too, sir.

1 Q. Okay. So then you also have the two cards to the left of  
2 the screen which -- one shows "LAPD," and the other one says,  
3 "Los Angeles Police" -- was that Federal Credit Union? Federal  
4 Credit Union?

5 A. Yes, sir.

6 Q. Okay.

7 A. The police card, I always carry, especially if I have a  
8 weapon on me. And the other card has my earning. That's my  
9 money, and I take pride of it -- I take a pride on it, too.

10 Q. So these -- these are all cards and identifications  
11 related to either your military or your law enforcement  
12 background?

13 A. Yes, sir.

14 Q. Showing you what's been marked as Government's Exhibit 9,  
15 this is a blowup.

16 Okay. What is this?

17 A. This is my Los Angeles Police Department credentials.

18 Q. Okay. So when you say "credentials," what is that? What  
19 does it mean?

20 A. This is a -- this is firstly to serve as an identity as a  
21 police officer. I use that as an ID card, and I use this ID  
22 card to access -- LAPD has about 21-plus police stations. So  
23 this card will give me entry to any police station, entrance to  
24 the police headquarters. This ID card also gives me access to  
25 any computer device that I'm going to use.

1 Q. Does this identify you also as a police officer?

2 A. Yes, sir.

3 Q. Does LAPD have gold badges or things like you see on TV  
4 for you, I mean?

5 A. At the police academy, they do give us a badge once you  
6 graduate, but I personally carry my badge -- I leave my badge  
7 in my locker at the police station because I don't want to use  
8 it. The badge doesn't really have a credential because it's a  
9 metal you can buy anywhere. So the ID card is the one that  
10 actually has your true credential that can be verified.

11 Q. That would be this ID card?

12 A. Yes, sir.

13 Q. Is this the ID card that you showed to the Border Patrol  
14 agents?

15 A. Yes, sir.

16 Q. All right. So you said that they -- you identified  
17 yourself as an LAPD officer off duty. Why did you do that?

18 A. The reason why I did that, sir -- you mean at the first  
19 checkpoint?

20 Q. Yes.

21 A. The reason why I did it is because, like I mentioned  
22 earlier, I was reaching for my wallet that is right next to the  
23 gun, and I had had bad experiences when people see --  
24 especially a law enforcement officer. You work on duty, and  
25 you see a guy that you don't know yet reaching --

1 Q. For the gun?

2 A. -- for the gun, a black man. I've had experiences.

3 Okay. And the second one is when he -- it's for his  
4 safety. If you will think about it, letting the officers know  
5 that I'm a police officer carrying a loaded firearm on my  
6 hips -- it's only going to take me about three seconds to draw  
7 that gun. I don't know what kind of training they have, but I  
8 could take that gun out of my -- the holster within three  
9 seconds. That is a safety issue.

10 So I'm letting them know. So let's all be at ease.

11 There's nothing going on here. Everything is quiet. Pretty  
12 much, that's what -- that's what I have in my mind, and the --

13 Q. Did you tell them you had a service revolver on you?

14 A. At the first checkpoint I didn't, because I only showed  
15 them the ID card. And then when he -- I believe he proceed to  
16 ask for the identity of the other people in my car.

17 Q. What did you say?

18 A. Well, I thought it was a safety issue because I'm the  
19 driver in a car. I showed you my ID. Officer sticks his  
20 head -- he literally put his head in my car. The gun's right  
21 here. Like I was saying, all it takes is two seconds to get  
22 this guy in the face. So I'm thinking we've got some safety  
23 issues here, Number 1.

24 Q. So what do you do?

25 A. I told them that I'm a police officer -- well, over there,

1 I told them I'm a police officer. I thought if I told them  
2 that I'm a police officer, if they see a gun, maybe -- they  
3 might connect it, like, "Let's investigate."

4 Q. Did you tell them anything about the citizenship status of  
5 the people in the vehicle with you?

6 A. No, sir.

7 Q. Okay. What did they ask you about -- or did they ask you  
8 anything about the people in the vehicle?

9 A. They never asked me at the first checkpoint -- they never  
10 ask me about the status of the people in the car. They asked  
11 them directly.

12 Q. And what did you -- so what did you do next after -- so  
13 they ask you about your status, and they ask the other  
14 occupants about their status. You've identified yourself as a  
15 police officer. You're at the primary. What happens next?

16 A. What happened next? I believe they direct me to go to  
17 secondary checkpoint, and then -- so I drove to the secondary  
18 checkpoint.

19 Q. Okay. Did you have any trouble getting to secondary?

20 A. Yes, I did. I did because there was a lot of  
21 miscommunication issues -- okay? -- from the second  
22 checkpoint -- from the first checkpoint to the second  
23 checkpoint, there was cones. There was all kind of lanes.  
24 There was no directions.

25 So, again, the only thing I can use is, you know, drive

1 Q. So, you know, Mr. Patara, as a police officer, you have  
2 testified in court before, I take it?

3 A. Yes, sir.

4 Q. You are aware of what it means to take an oath to tell the  
5 truth?

6 A. Yes, sir.

7 Q. And you've taken that oath before?

8 A. Yes, sir.

9 Q. And you've taken it here today?

10 A. Yes, sir.

11 Q. Did you at any --

12 MR. COUGHLIN: I'd object to this as vouching.  
13 Bolstering.

14 THE COURT: I'll allow it.

15 BY MR. CARLOS:

16 Q. Did you -- at any time on the 23rd while you were going to  
17 Temecula, did you -- did you conspire or agree with Mr. Ramirez  
18 to assist him in bringing Mr. Lopez into -- I mean, to a place

20 A. No, sir.
