## ORDER AFFIRMING DENIAL OF POST-CONVICTION RELIEF

Respondent.

Petitioner, pro se, appeals the denial of post-conviction relief by the District Court of Mayes County in Case No. CF-1999-105. Before the District Court, Petitioner asserted he was entitled to relief pursuant to *McGirt v. Oklahoma*, 140 S.Ct. 2452 (2020). In *State ex rel. Matloff v. Wallace*, 2021 OK CR 21, \_\_\_ P.3d \_\_\_, this Court determined that the United States Supreme Court decision in *McGirt*, because it is a new procedural rule, is not retroactive and does not void final state convictions. *See Matloff*, 2021 OK CR 21, ¶¶ 27-28, 40.

The conviction in this matter was final before the July 9, 2020 decision in *McGirt*, and the United States Supreme Court's holding in *McGirt* does not apply. Therefore, the District Court's order denying

post-conviction relief is **AFFIRMED**. Pursuant to Rule 3.15, *Rules of the Oklahoma Court of Criminal Appeals*, Title 22, Ch.18, App. (2021), the **MANDATE** is **ORDERED** issued upon the delivery and filing of this decision.

## ORDER LIFTING STAY AND DENYING POST-CONVICTION RELIEF APPLICATION

Now on this 13<sup>th</sup> day September, 2021, after having reviewed the file and pleadings herein and the post-conviction relief application of the Petitioner and any response filed on behalf of the State of Oklahoma, the Court finds as follows:

- 1. At the time of Petitioner's initial filing for post-conviction relief, a final determination of the effect of *McGirt v. Oklahoma*, 140 S. Ct. 2452 (2020), in Oklahoma had not occurred.
- 2. The case of *Oklahoma v. Bosse*, 2021 OK CR 3, that appeared to be controlling, was appealed to the United States Supreme Court. Its implementation as controlling law in Oklahoma was stayed by the Oklahoma Court of Criminal Appeals while the case was being reconsidered.
- 3. As a result of the Oklahoma Court of Criminal Appeal's stay order, this Court stayed its decision regarding Petitioner's post-conviction relief application, awaiting further instruction regarding the interpretation of *McGirt* on post-conviction relief applications. Petitioner's application claimed this Oklahoma court lacked jurisdiction to hear Petitioner's case, therefore the Petitioner's original conviction should be vacated.
- 4. Since this Court's stay order, the Oklahoma Court of Criminal Appeals has issued State v. Wallace, 2021 OK CR 21. In Wallace, the Oklahoma Court of Criminal Appeals held that,

"McGirt and our post-McGirt reservation rulings shall not apply retroactively to void a final state conviction." Wallace at ¶40.

- 5. In addition to issuing the Order in Wallace, the Oklahoma Court of Criminal Appeals vacated Bosse and other cases that were inconsistent with their holding in Wallace. (See, Bosse v. State, 2021 OK CR 23, Bench v. State, 2021 OK CR 24, Ryder v. State, 2021 OK CR 25, Cole v. State, 2021 OK CR 26).
- 6. Petitioner's application for post-conviction relief is necessitated upon the retroactive application of *McGirt* to support the claim that Oklahoma did not have subject matter jurisdiction over Petitioner at the time of the disposition of Petitioner's case.
- 7. This Court finds, as a matter of law, based upon the Oklahoma Court of Criminal Appeals decision in *State v. Wallace*, 2021 OK CR 21, that Petitioner's post-conviction relief application should be denied. Regardless of the "Indian" status of the parties and whether the crime occurred on "a reservation," *Wallace* precludes the application of *McGirt* retroactively to void a final state conviction.

Petitioner's post-conviction relief application is hereby denied. The hearing previously set for September 27, 2021, is hereby stricken as moot.
