**ORDER TRANSFERRING PETITION FOR WRIT OF HABEAS CORPUS TO THE
FOURTEENTH JUDICIAL CIRCUIT IN AND FOR CALHOUN COUNTY FOR
CONSIDERATION AS A POSTCONVICTION MOTION**

THIS CAUSE came before the Court on Sammy Lee Gibbs' ("Petitioner") Petition for Writ of Habeas Corpus ("Petition"), filed with the Clerk on August 12, 2019. The Court has carefully considered the Petition, the court file, and is otherwise fully advised in the premises.

Petitioner was found guilty of First Degree Felony Murder and Robbery with a Deadly Weapon and sentenced to life in prison on or about February 27, 1987, by the Circuit Court for the Fourteenth Judicial Circuit in and for Calhoun County, Florida (case numbers 071986000071CFAXMX and 071986CF000072CFAXMX). Petitioner attacks the charging instrument in his Calhoun County case, alleging the amendments to the Indictment rendered the Indictment void and constituted manifest injustice.

To obtain relief through a petition for writ of habeas corpus, a petitioner must show he is "unlawfully deprived of his liberty and is illegally detained against his will." *Smith v. Kearney*, 802 So. 2d 387, 389 (Fla. 4th DCA 2001). The writ of habeas corpus "is designed to test solely the legality of the petitioner's imprisonment." *Sneed v. Mayo*, 66 So. 2d 865, 869 (Fla. 1953). To the extent Petitioner attempts to raise an argument challenging the validity of his conviction or sentence, he must do so pursuant to Florida Rule of Criminal Procedure 3.850 or 3.800. See *Harris v. State*, 789 So. 2d 1114, 1115 (Fla. 1st DCA 2001) ("habeas corpus may not be used as a substitute for an appropriate motion seeking postconviction relief pursuant to the Florida Rules of Criminal Procedure"). Petitioner's writ of habeas corpus seeking to collaterally attack his

conviction and sentence based on an allegedly void Indictment is improper and should be re-filed as a postconviction motion. See *Baker v. State*, 878 So. 2d 1236 (Fla. 2004). Further, although Petitioner is incarcerated in South Bay, Florida, he was sentenced by the Fourteenth Judicial Circuit in and for Calhoun County, Florida. Jurisdiction over any postconviction motion, therefore, lies with the same court that imposed the judgment or sentence which is being collaterally attacked—not the county in which the prisoner is incarcerated. *Leichtman v. Singletary*, 674 So. 2d 889 (Fla. 4th DCA 1996). See also *State ex rel. Renaldi v. Sandstrom*, 276 So. 2d 109, 110 (Fla. 3d DCA 1973).


Although Petitioner states no claim upon which relief may be granted through a petition for writ of habeas corpus, a motion for postconviction relief is the proper vehicle for Petitioner's claims. Therefore, this Court construes the Petition as a motion for postconviction relief, and finds that the Petition must be transferred to the court that imposed Petitioner's judgment and sentence.

Accordingly, it is hereby

ORDERED that the Petition for Writ of Habeas Corpus is hereby **TRANSFERRED** to the Circuit Court for the Fourteenth Judicial Circuit in and for Calhoun County, Florida (case numbers 071986000071CFAXMX and 071986CF000072CFAXMX) for consideration as a motion for postconviction relief. The Clerk of Court is further directed to close this case number (50-2019-CA-010315-XXXX-MB).



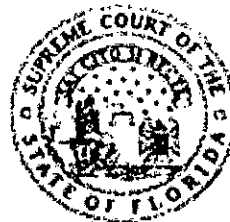

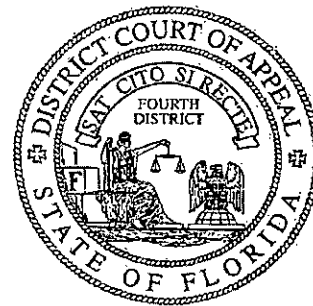
