





After hearing testimony from the parties and their witnesses, the Court finds in favor of the Plaintiff.



FINAL ORDER

Following the conclusion of Plaintiff's evidence, the Plaintiff rested. No motions were made by Defendant at conclusion of the Plaintiff's case. 




