I represent Respondent in the case referenced above. Petitioner Oklahoma filed petition for a writ of certiorari on October 30, 2021, and this matter was placed on the docket on November 2, 2021. Respondent's response to the petition is due on December 2, 2021. Pursuant to Supreme Court Rule 30.4, I write to request a fourteen (14) day extension of time to file a response to the petition in this case.

In light of the press of other business, counsel requires additional time to complete the response to the arguments presented in the petition. In particular, undersigned counsel is presenting argument in a preliminary-injunction hearing that was just set for Friday, December 3, in *North Carolina League of Conservation Voters, Inc. v.
