MOTION

Petitioner Michael Stumph (“Stumph”) respectfully requests leave to file the attached Petition for a Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis*.

This relief is warranted because during all phases of the proceedings below Stumph sought similar relief and counsel was appointed to him. Counsel was appointed by the Hamilton County Court of Common Pleas on January 6, 2017 to represent Stumph in the capital trial proceedings for *State v. Stumph*, No. B-1607280. *Entry attached at Apx. 0001*. On September 21, 2017, the Hamilton County Court of Common Pleas appointed a mitigation specialist for the case to be paid at public expense. *Entry attached at Apx. 0002*.

Counsel was appointed by the Hamilton County Court of Common Pleas on May 21, 2019 and May 29, 2019, respectively, to represent Stumph in his direct appeal before the Court of Appeals of Ohio, First Appellate District in *State v. Stumph*, No. C-190318. *Entries attached at Apx. 0004 & 0005*.

As further grounds for relief, Stumph has been incarcerated in the Warren Correctional Institution on a sentence of life without the possibility of parole without the opportunity to maintain employment during the years-long pendency of these proceedings. He therefore remains indigent and unable to hire counsel.

For the foregoing reasons, Stumph respectfully requests leave to file the attached Petition for a Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis*.






