

STATEMENT OF THE CASE

On September 6, 2017 petitioner was indicted by a grand jury held in Alcorn County, Mississippi, for the crime of AGGRAVATED ASSAULT shooting into a dwelling and a felon in possession of a FIREARM.

On July 29, 2019 trial began and this petitioner was convicted upon all counts and was sentenced to 20 years for two counts of AGGRAVATED ASSAULT to run consecutive to one another. 10 years suspended for the

charge of shooting into a dwelling to run consecutive to the assault convictions, and 10 years suspended for the charge of a felon in possession of a firearm to run consecutive to the assault and shooting into a dwelling convictions.

Petitioner court-appointed counsel appealed the case which was heard by the Mississippi Court of Appeals. On January 26, 2021 the Mississippi Court of Appeals affirmed this petitioner's convictions.

On February 7, 2021 petitioner sought certiorari review by the Mississippi Supreme Court. The Mississippi Supreme Court found that the petition for certiorari was untimely initially, but after this petitioner submitted proof that the petition was timely the Mississippi Supreme Court then reinstated the petition, but denied this petitioner's request for certiorari review on September 28, 2021.

REASONS FOR GRANTING THE PETITION

This Honorable Court should grant this petition BECAUSE the Mississippi Court of Appeals decision is contrary to this Court's decision RENDERED in Jackson v. Virginia, 443 U.S. 307 (1979)


THE Mississippi Court of Appeals misapplied Jackson v. Virginia in a way that would not take into account the fact that the victims admitted to using a hallucinogenic drug moments prior to the shooting.

No one testified that this petitioner EVER had a gun, but yet this petitioner has been convicted of a felon in possession of a firearm, shooting into a dwelling and two counts of AGGRAVATED ASSAULT.

CONCLUSION
