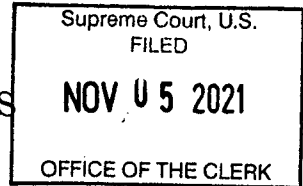

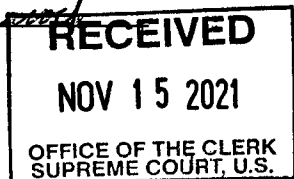

Stephen argues in his Pulitzer Finalist book, that girls at a younger age begin looking for a life partner; that they are looking for stability, safety, happiness and love as a proximate causation (immediate need/want) and to produce the strongest genetic offspring as ultimate causation. Lt. Col. Grossman is one of the world's leading scholars on the causes and effects of extreme mental trauma and injuries on the battlefield, including P.T.S.D. As a noted war historian, he looks through a vast amount of data collected on America's wars going all the way from the Civil War through W.W.I, W.W.II, Vietnam War, Korean War, and so on up until today. What he discovered, and which is the main point of his book, is the amazing correlation between the rate of incidence of P.T.S.D. and the specific proximity of combat a soldier engages in with an enemy soldier. Hand to hand combat had the highest rate of P.T.S.D. followed by close range combat, medium range combat, snipers, then artillery and bomber pilots having the least rate of P.T.S.D. The absurdity of such a result with its attendant likelihood of unfair punishment and blackmail, is sufficient by itself to foreclose that construction."

Unfortunately, Congress did not listen to Justice Murphy and did just that; unfairly punished and blackmailed the U.S. population by issuing broad sweeping legislation that lumps people with good intentions into the same boat as predators and treats them exactly the same.

Chapter 8, "Man, Woman, and State"
Mr. Roche was the President of Hillsdale College several decades ago, which was one of only two colleges that fought against U.S. Government Legislature and intrusion into the lives of its students by demanding Hillsdale release the sex, age, and race of its own students.

Speaking of women, "Born to motherhood, she is innately closer to the biological nature of life, and she understands it better than the male... they have to be taught... From this beginning, the woman will maintain the moral directions and leadership of her home."

A marriage is an incredible thing - every effort must be made not to break it up. It channels male aggression into a providing role, a role he needs (most violent crimes are committed by single, unmarried 15-25 year old men), gives children the support they need (children in broken, single family homes, statistically speaking, are several times more likely to drop out of school, use drugs, end up in prison or commit suicide) and give women sincere fulfillment, love, and happiness.

I grew up in a broken family, I saw first hand, everyday, the devastation it brought. It's why I lost my faith in legal marriages - which is nothing but an easily dissolvable piece of paper.

I made a promise to always protect her, and I will keep that promise, no matter what. I love her and care for her greatly and miss her everyday. We discussed future plans together and helped each other through the dark moments in our lives. Here are her own words, taken from off of her own laptop, to me and to others when speaking of me.

"... because I love you like no one else... you hold both halves of me together.."

"I was gonna attempt suicide again, but I waited for you to get off of work."

"I was going to attempt suicide but you kept me from it..." (2 separate times she claimed I stopped her)

"I've never been loved like this before. He's taking such good care of me."

"I just need to be in your arms again."

"It's my job to protect you."

"I love you... It'll be okay, don't worry..."

"As long as I can have you to myself"

"I've never been this happy before"

"Nick where are you? I need you. I miss you. I need to make sure you're okay" (Her last message to me, thanks to the Sheriff). I still miss her.

Current Federal and state sex offense laws do not discriminate between behavior that is exploitative, and behavior that is for the purpose of being in a relationship with and supporting another, such as for marriage purposes.
