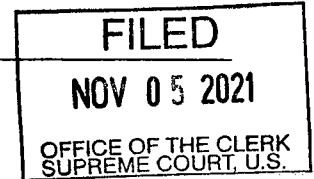

Petitioner has previously been granted leave to proceed in forma pauperis in the following courts;

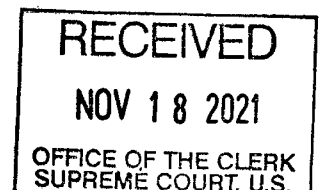



Especially since, as this case covers, I will have no knowledge of the tools needed to re-entergrate into a high-teck society.
