

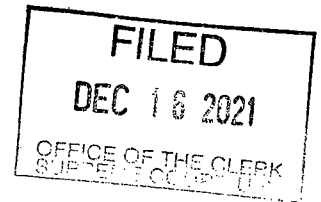

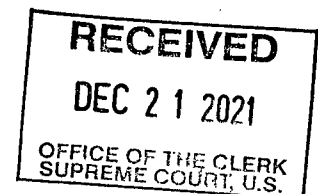
MOTION FOR LEAVE TO PROCEED *in Forma pauperis*


