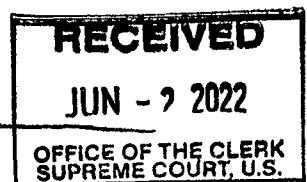

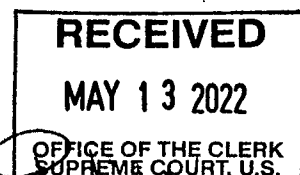

Petition for Rehearing

Pursuant to Rule 44 of this Court, the acting Solicitor General, on Behalf of the United States and the other petitioners, hereby respectfully petitions for rehearing of this case before a full nine-Member Court. On February 23, 2021 an order was put in for termination of my rights. On May 21, 2017 I Jodie Tanner was the person who called in the fact that my children had been abused by my ex paramour ~~man~~ ~~man~~.

Reason For Granting Rehearing

I Julie F. Tanner am accused of leaving my three children R.T., S.S., & J.S. with a registered sex offender, which resulted in the loss of my parental rights, when in fact the Courts are wrong. The allegations on the paperwork from the beginning of the case (May 12, 2017) are actually inadequate supervision and neglect. I was forced to plea guilty to that allegation. I did not leave my children with my at the time partner Mark F., we were both incarcerated together, I left my children with my at the time best friend that was actually living with me at the time Shame O., Mark F. admitted to leaving my three children alone due to missing Court/in fear of a warrant. My children disclosed to myself at our first visit May 21, 2017, when I was released from jail (May 19, 2017) and to the caseworker at the time Patricia that they had been hurt by Mark F., after the visit I filled a Police Report with the Spartan Illinois Police Office, Randolph County Illinois, for Mark F. Physically & Sexually abusing my children. He has yet to be arrested or even questioned. I have been held responsible for what he did to my kids, I want justice for my children if nothing else. All I have is my love & my story, I am asking for the opportunity to right my wrongs for the sake of my family. In this five year case I have been instructed with made up allegations from the foster mom 7 times,

which has prevented me from seeing my children / being a part
of their lives. I am asking for the Courts to see that my case
has been taken to the extreme with cruel and unusual punishment.
I have also been investigated and found guilty in Williamson
County Illinois for the exact same allegation of Inadequate
Supervision and Neglect with the allegation of Sex trafficking
my daughter SS. Because of a false report from the father
mother, the allegation of Sex trafficking took nine months to
be ruled unfounded, I was never given a notice for court or even
allowed to be a part of it, I was indicted and never got
the chance to face my accusers or have the Right to a Fair
hearing trial.

I am asking for your courts to see that my children
and myself have been wronged by the department of Children and
Family Services as well as the Caritas House.

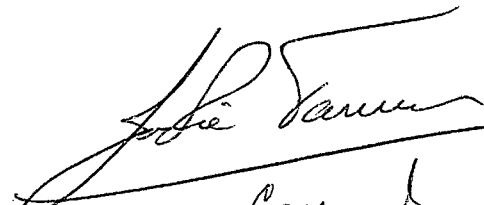
As a person who has been in the foster care system herself
and come from a broken home I know its hard for people to
believe that there are people out there that break the statistics.
As a child I was molested, raped and sold by my father,
mother and mother's paramour I know what its like to not
be loved or to have a person not believe in you

but I want the Courts to see that there are
people out here that do change and reform for the better.
I'm not the Greatest but I am a senior and I
want to show the world that you can change for the
better and the hard work does pay off. To have my
family back and whole again I have voluntarily went to
rehab, I asked for the help to make the right decisions
and it was used against me, I have completed my service plan
and then some and its still not good enough for the
Judge that lost against me as a child when I sent my
Parents to Prison at 16, Honorable Judge Richard Brown
of Randolph County Illinois. How do you get a fair hearing
with a Judge that already has an issues with you, Conflict of
interest and prejudice to the fullest. You don't have
Constitutional Rights in this County and someone needs to
stop the abuse of power here. Please find it in your hearts
to help me save my family and my community. Thank you.

My Civil American Rights in this Case
have been violated to the fullest. My fifth
Amendment Right (double jeopardy), to not be tried
twice. My Sixth Amendment Right (Right to Confront
my accusers & to Counsel), my Eighth Amendment
Right (Cruel and unusual punishment), I just want
to ask for the Right to be heard by the
Courts and the justices. I haven't seen my daughter
in four years and I haven't seen my sons in
over a year. I have been ~~harmed~~ ^{harmed} seen times
by the Foster Mother or false accusers. I
have been indicted in two Counties for the
same Case. Williamson County and ~~Franklin~~
County.

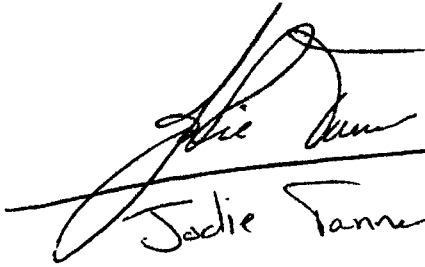
