The Texas Forensic Science Commission issued a report on April 12, 2016, finding evidence of "professional negligence" when firearms analyst Heather Thomas (an employee of the Dallas County Southwestern Institute of Forensic Sciences) misidentified a firearm as having fired bullets recovered from the deceased in a case in Grimes County.

Our records indicate you were prosecuted for a criminal offense and either convicted or placed on Community Supervision in relation to evidence tested/analyzed by Heather Thomas.

See Tex. Gov't Code § 552.028(a) (Vernon Supp. 2016).

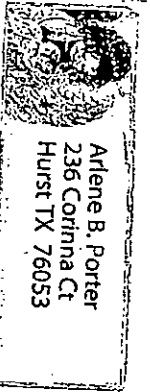

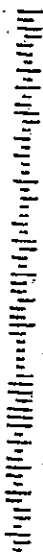

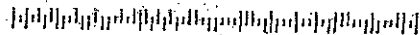

G. I hope I have relieved your mind a little about your court situation. I've been there for you since the beginning, and I will stay with you to the end - the Good Lord Willing!



1. Cf. ABA Standards for Criminal Justice, Standard 4-4.1, at 4-53 (2d ed. Supp. 1986), entitled Duty to investigate:

It is the duty of the lawyer to conduct a prompt investigation of the circumstances of the case and to explore all avenues leading to facts relevant to the merits of the case and the penalty in the event of conviction. The investigation should always include efforts to secure information in the possession of the prosecution and Law enforcement authorities. The duty to investigate exists regardless of the accused's admissions or statements to the lawyer of facts constituting guilt or the accused's stated desire to plead guilty.

Commentary to Standard 4-4.1 notes that "[f]acts form the basis of effective representation . . .

Adequate investigation may avert the need for courtroom confrontation.

The resources of scientific laboratories may be required to evaluate certain kinds of evidence:

- ... ballistics tests may be necessary.

- ... these steps may preclude the presentation of an effective defense." *Id.* at 4-54.
