PETITION FOR REHEARING

The Petitioner, Cristian M. Loga-Negru, respectfully asks the Court pursuant to Rule 44.6 for a rehearing of the petition for a Writ of Certiorari to which a judgment was issued on March 28, 2022. The following grounds are tendered to support this request:

1. The Petitioner experienced loss of property since the beginning of his preparation for submitting the Petition for a Writ of Certiorari, and the only meaningful post-depravation remedy was the purchase of the six volumes of the Wisconsin Statutes and Annotations, edition 2019-2020.
2. The purchase receipt was already submitted to the Court, along with an explanation of the intervening circumstances represented by the updates of the substantial laws applicable to the issue presented in the Petitioner's Petition and attached supplements. The Official limitation on the legal material an inmate can keep affects the understanding of his case and controls the progress of his knowledge.
3. As an example, the Constitutional Joint Resolution from 2019-2020, related to Section 9m of the Wisconsin Constitu-


tion, amended on April 2020, may have impacted or changed retroactively the value of the prosecutor's charging decision, and as a consequence, the meaning of the petitioner's argument related to this issue.

4. The legislative intent of strengthening the victims role in the criminal process, and their rights to speedy resolutions, could also change their involvement during the plea bargaining and thereby the amount of disclosures afforded to the accused.

Based on the foregoing, the Petitioner respectfully submits that his petition for rehearing is reasonably justified.
