REASONS FOR GRANTING THE MOTION

- Note: I am representing myself without an attorney. I am not an attorney and I have never taken any law classes or legal training. As a result, I apologize if this document does not perfectly conform to the requirements of the court.

Honorable Justice Sonia Sotomayor,

I am a Pro-Se and IFP plaintiff/appellant/petitioner. I am filing this motion/petition to respectfully request permission to exceed the page limits for my Writ of Certiorari. According to Rule 22, this motion is for the Justice allotted to the Second Circuit from which my case arises.

- Rule 33.2.(b) Page limits for documents presented on 8.5 by 11-inch paper are: **40 pages** for a petition for a writ of certiorari.

On December 21, 2021 I mailed SCOTUS the first version of this motion request. That first motion was received by SCOTUS on December 28, 2021. However, it was mailed back to me by SCOTUS on December 30, 2021 with a letter from the court clerk. The letter notified me that I need to resubmit this motion with my IFP form, writ of certiorari, appendix, and proof of service. Based upon that, I have enclosed in this mailing:

1. This Motion to Exceed Page Limits - 1 original + 2 copies as required by Rule 22.
2. The December 21, 2021 mailing proof of service with the confirmed receipt stamp by SCOTUS of December 28, 2021
3. The SCOTUS court clerk letter dated December 30, 2021
4. My IFP form - 1 original + 10 copies
5. My Writ of Certiorari - 1 original + 10 copies
6. My Appendices documents - 1 original + 10 copies
7. My Proof of Service - 1 original


The deadline to file my writ is 90 days after the November 3, 2021 ruling by the US Court of Appeals for the Second Circuit. I respectfully request permission to include **an additional 20 pages**. The additional pages over the 40 page limit are needed due to:

- I need to present detailed legal arguments, court precedents, and the remedy to support the points raised in my writ of certiorari.
- At oral argument, the **three Justices at the US Court of Appeals for the Second Circuit** said that this case has ***“profound legal and Constitutional issues that the US Supreme Court has to decide”***.
- I need to reference the Appendix documents related to **both** this case and the underlying case which was my prior Writ of Certiorari, docket No. 19-6822 submitted to SCOTUS on November 29, 2019.

Conclusion

I respectfully ask Justice Sotomayor and SCOTUS to approve my motion to exceed the page limits for my Writ of Certiorari.
