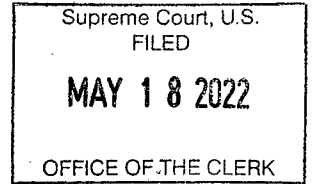

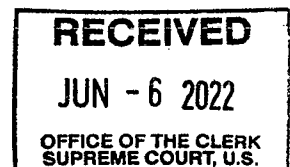

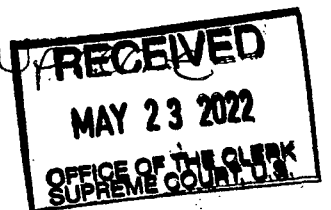

Dear Scott Harris and United States Supreme
Court Justices;



I, Alma Aisha Walker, natural born
Citizen of The United States of America, protected
by The Constitution of The United States of America,
which was "established to form a more perfect union,
ESTABLISH JUSTICE, insure domestic tranquility,
provide for the common defense, promote the general

Welfare, and secure the blessings of Liberty...." (2)
I am writing this petition for rehearing of the
above documented case NO 21-746.

Since my seventh grade year of middle school and throughout my Policy Studies at The Georgia State University School of Policy Studies, I was made aware that "Landmark Supreme Court Cases" are cases that are usually complex in nature which address an emergency need to protect and/or address individual or collective human rights and liberties. These cases often leave a long-lasting impact on the lives of The American People and often result in the creation of new legislation. My case is no different.

In my original Writ of Certiorari, I documented the various reasons why my case should be heard by the U.S. Supreme Court. Many of these reasons can be categorized as Racketeering offenses by Judges and Public Officials. Racketeering is a serious criminal offense in our country, yet even people entrusted with the high honor of protecting and serving women and children under oath

Commit these racketeering offenses. If judges, attorneys and social workers are committing actions which are identified as kidnapping under the DC Code 22-2001, Intimidation, Coercion etc - then what measure of LIBERTY does our country have if these actions by its own officials go unpunished, ^{and} or if they result in the punishment of an innocent mother who was acting in accordance with her religious beliefs?

These racketeering actions which I described in my writ, were intended to humiliate me and attack my mental health. From the moment The Bad Faith Call was made by Amtrak Police Officer Little, to the moment

D.C. Child Family Services Investigator Lone

Cyphers (who is related to an professional enemy of mine Marlanna Evans) told me to "enroll my children in DC Homeschool or he would take them from me" when they were already enrolled in GA Homeschool, the state which we were residents of to the moment in which my explaining that my lack of communication

with relatives and the children's father was due to being a Survivor of Domestic Violence... to the bullying and FRAUD of Judge Julie Breslow who, during the Initial Hearing... (which I signed in and stated I was participating in UNDER DURESS) entered a diagnosis of *mental incapacitation* for me, stating that "Intelligence and Incapacitation are two different things" as her justification... from

Terri Buchinski, DC Social Worker, Intimidating me during visits and phone calls, ignoring my request for reasonable accommodations for my bladder cystocele, which reversed or worsened during the case, to Attorney Ronald Colbert telling me that my Domestic Violence made me mentally incapacitated, despite my intelligent questions presented, despite my research and statistics mentioned, DESPITE THE VERY ETYMOLOGICAL MEANING OF INCAPACITATION, Despite my pleading for my children for 9 and 11 years by myself or in lieu of participation in programs for Survivors of Domestic Violence,

2. All of these moments are instances of corrupt (5) actions, perhaps for reasons that may be due to racism on their behalf, "Classism", religious discrimination, disability discrimination, sexism, sexual harassment, or perhaps even, premeditated kidnapping attempts... considering the fact that Lane Cyphers is in fact related to Markanna Evans.

Another Reason for Reconsideration is the blatant disrespect and inconsideration of my observing my Christian religious practices being misconstrued as being delusional. *Christianity is the most prevalent religion in The United States of America, with 70% of American Citizens being Christian according to the Public Religion Research Institute 2020 Census. In my original writ I stated that on numerous occasions "I was instructed by God to purchase tickets and rest at Union Station during the evening / early am hours.) I also recited Biblical Scripture which states "My sheep hear my voice" and described my entrepreneurship as a Christian Motivational Speaker" in other words "a shepherd" (John 10:27-28 Bible)

Why thereby was "Mobile Crisis" called because (4)
my children and I were crying IN STOCK
at the statement that Mr. Cyphers would be
removing my children from my care... because we
were reciting Bible verses? Even then when
Mobile Crisis came, they deemed me to
NOT be harmful to myself and others
but to be delusional? This makes no sense - yet
I am the one who was given a mental
Incapacitation judgement?

Finally, On November 18, 2018, I
provided Mr. Cyphers with receipts for healthy foods,
showed him clean clothing neatly packed in a suitcase,
shoes, coats, yet he said my childrens coats were
not appropriate for the weather but they were
insulated and my daughters were two thinner
jackets put together, because she gets over-
heated easily. Hygiene products, toothbrushes
with covers, were provided. Assignments from
homeschool were not sufficient to Mr. Cyphers
yet I have 10 years of experience educating
children in early elementary and after school
settings, and private and Advanced Charter
School settings? This seems Corrupt.

∴ If this case is not heard by Supreme (7)
Court Justices, what will this teach our citizens?
Will it teach them that Government Officials
and Social workers, etc can get away with
their corrupt actions and change the entire scope
of someones life simply because of their
EGO, racism, sexism, or failure to understand
someones Religion or Domestic Violence Trauma?
Will it teach our citizens that Justice for
all does not include Black women,
Christians, Single Mothers, Functioning Disabled
Citizens?

Not only should this case be heard by
The United States Supreme Court, a Criminal
Investigation of all Government Officials,
attorneys, Judges, social workers, DC CFSA
staff involved should be conducted, in order
for JUSTICE to properly be insured for my
family.

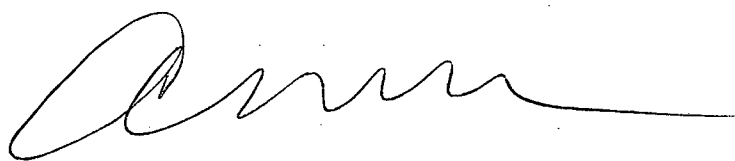

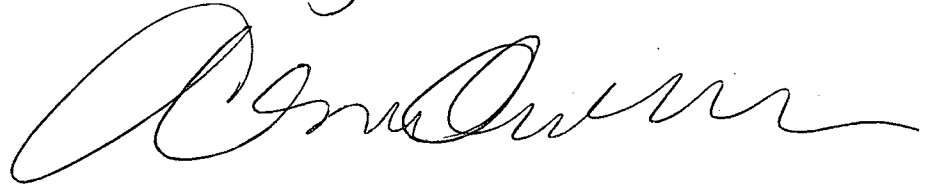

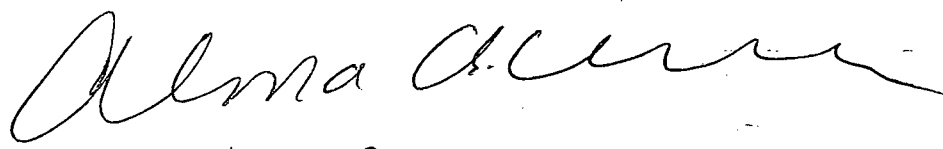
