That probable cause exists to cause the arrest of Edward Renar Brown Sr. for the public offense against said County and State, to wit:

Offense, Burglary in the Second-Degree (S21-1435)

And that probable cause of the Affiant believing such facts exist as follows, to wit:
In the State of Oklahoma, County of Comanche, and the City of Lawton, on 9/20/2020, at approximately 1000 hours. Anette Allen was in her back yard located at 1328 NW Taft. Allen heard a noise coming from the detached garage located at 1330 NW Taft. Allen and her boyfriend, Martin Isham, manage several properties on the 1300 block of NW Taft, including 1330 NW Taft for Evergreen Capitol LLC. Allen looked through her fence and noticed a bicycle outside of the garage. Allen went to investigate and observed two males, later identified as Edward Brown and Taven Jackson, walking away from the garage. Brown was carrying a large mirror. Allen confronted the two men. Jackson stated that he was never in the garage. Brown began to apologize to Allen and stated that he was in the garage, but he did not know it was Allen's garage. Brown then stated that his family owned the property.


Martin Isham inspected the property and observed damage to the door frame that was not there previously.






